## FIFTH LINE IMPROVEMENTS BRITANNIA ROAD TO DERRY ROAD CLASS ENVIRONMENTAL ASSESSMENT STUDY NOTICE OF STUDY COMMENCEMENT

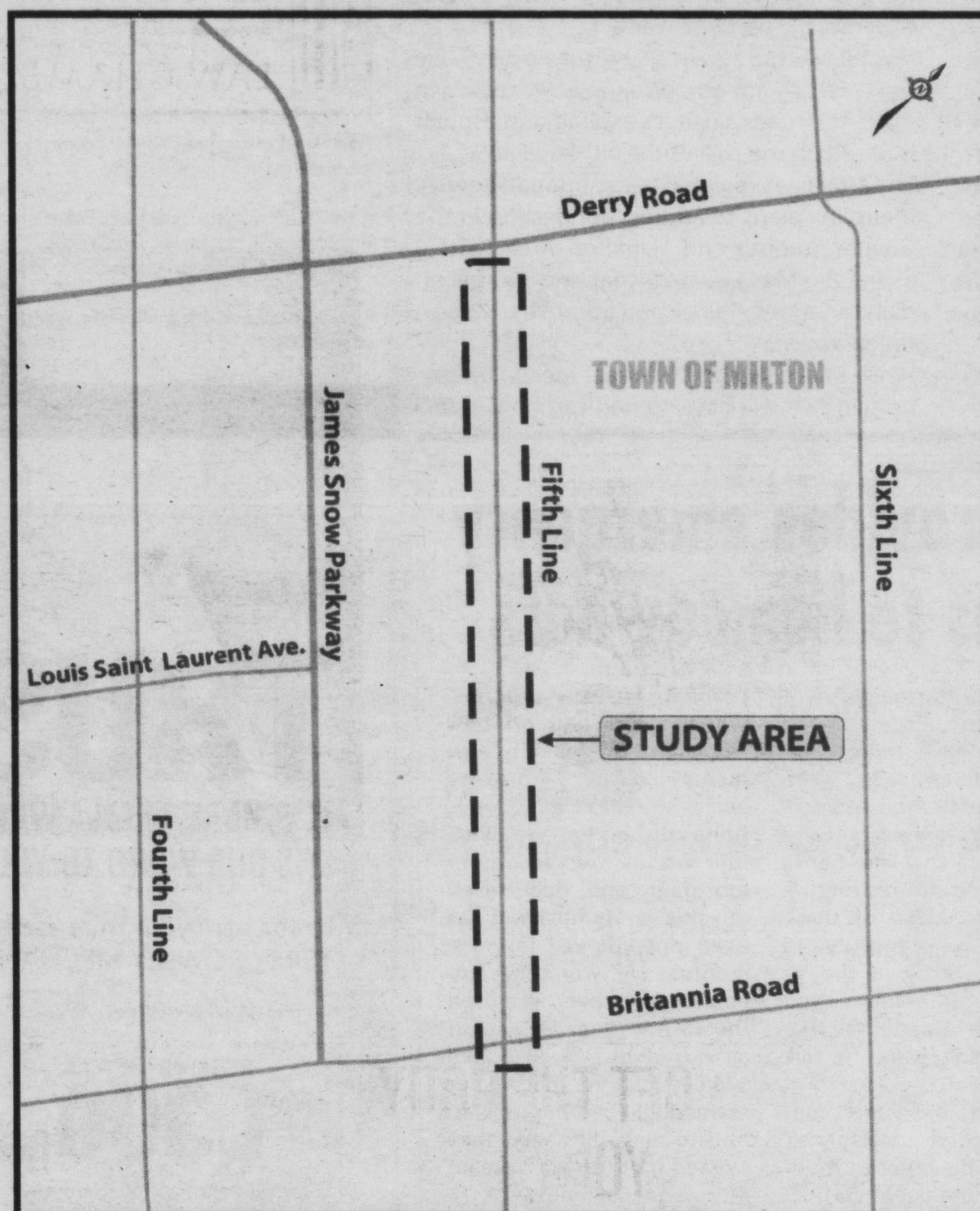
The Town of Milton is initiating a Class Environmental Assessment (Class EA) Study for the improvements of Fifth Line between Britannia Road and Derry Road. The Class EA Study is being undertaken in accordance with Schedule 'C' of the Municipal Class Environmental Assessment process (2000, as amended in 2007 & 2011), which is approved under the Ontario Environmental Assessment Act. MMM Group Limited has been retained to assist with the study. The study area is shown on the key plan.

Fifth Line between Britannia Road and Derry Road is an existing two-lane rural roadway. Lands on both sides of Fifth Line are part of the Derry Green Corporate Business Park, and are mainly designated for business uses. Lands in the south part of the study area are designated for agricultural uses. The Class EA Study will evaluate the need for roadway improvements to support future growth of the Derry Green Corporate Business Park.

The Class EA Study will identify the problem and opportunities, assess the alternative solutions and preliminary design concepts to address the potential environmental effects, and determine the preferred alternative.

Public consultation is a key component. The public will be invited to attend Public Information Centres that will be scheduled as the study proceeds. For further information on this Class EA Study, or if you wish to be put on the study mailing list, please contact:

# Police issue street drug warning

Halton Regional Police have issued what they call a serious warning about the use of illegal drugs following three incidents in which area residents suffered adverse side effects. Five victims were taken to hospital recently due to the use of illicit street drugs or medication, according to police.

One incident involved three people. Halton police issued the public safety alert regarding what they say was the misuse of prescription drugs (opiates) and illegal use of heroin and MDMA, also known as 'molly' or 'ecstasy'.

Det. Sgt. Brad Murray, head of the service's Drug, Gun and Gang Unit, said he can't release details about the ages or genders of the victims, their current condition or even whether anyone has died.

He did confirm that at least one victim came from each municipality in Halton — Burlington, Oakville, Milton and Halton Hills.

Murray added that police are seeing more people suffering severe reactions to legal and illegal drug use through the abuse or purposeful misuse of the product.
