Residents, and so many others asking for a recount. As most everything has a process to follow, asking for a recount is no exception," she said.

According to Town Clerk Troy McHarg, six council members signed a petition supporting the decision to hold the meeting — Arnold Huffman, Rick Di Lorenzo, Colin Best, Cindy Lunau, Zeeshan Hamid and Gord Krantz.

"A recount is not uncommon, but there wasn't one in Milton in 2003, 2006 or 2010," said McHarg.

Aside from a petition, the only other way a recount could be requested is through the mayor's office. If a recount is decided Monday, council will have 15 days to carry it out.

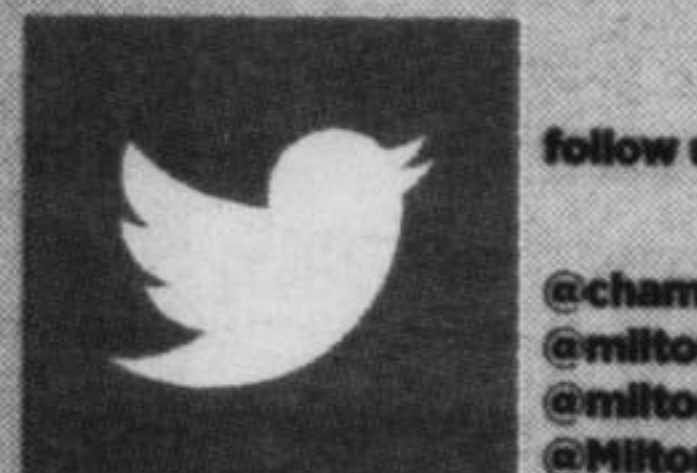
The council meeting is open to the public and will begin at 6 p.m. at Town Hall.

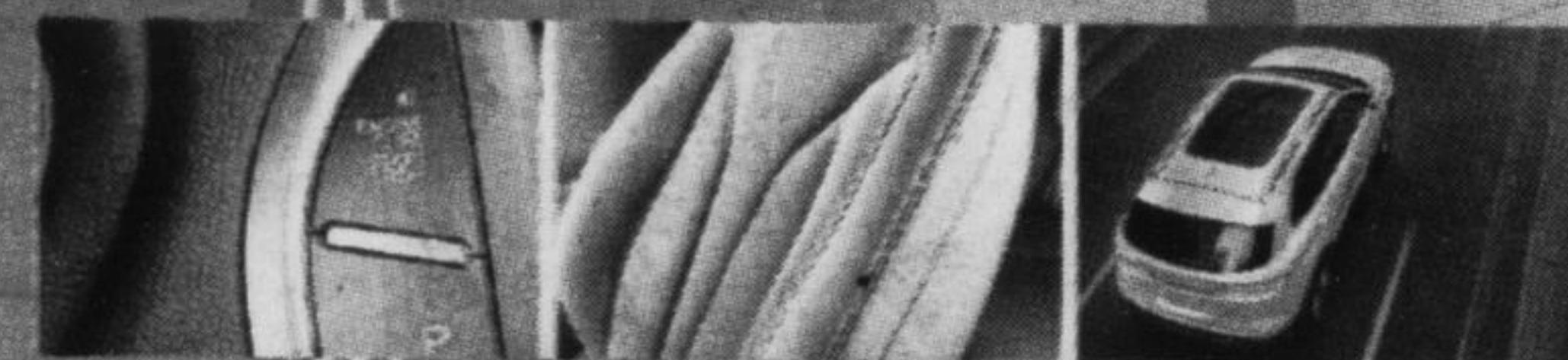
