Boyne Survey Community Collector Road Sixteen Mile Creek Crossing Municipal Class Environmental Assessment Notice of Study Completion

The Study

The Town of Milton has completed the Class Environmental Assessment for the proposed bridge crossing of Sixteen Mile Creek east of Regional Road 25, as shown on the key plan. This is in accordance with the Boyne Survey Secondary Plan Transportation Strategy Report. The Sixteen Mile Creek crossing connecting the Community Collector Road is completing Phases 3, 4 and 5 of the Class EA process as per the Town of Milton Transportation Strategy Report.

The study identified and evaluated a variety of location and design alternatives for the proposed crossing of Sixteen Mile Creek, including cross sections, which will include pedestrian and bicycle facilities.

In support of the creek crossing and road extensions, the study has included an analysis of Structural, Drainage, Geomorphology, Utilities, Archaeology, Cultural & Built Heritage, and Natural Environment components.

Key Elements of the Recommended Design

The study recommends:

- Construct a bridge crossing of Sixteen Mile Creek east of Regional Road 25, connecting the Community Collector Road in the east and west;
- Multi-span precast concrete 11 girder structure;
- 26 metre road allowance; Four (4) 3.35 m wide through lanes, Two (2) 1.5 metre cycle lanes; 3.0 metre sidewalk on both sides;
- Four (4) span bridge structure, including concrete curb and gutter;
- Stormwater management, to be coordinated with proposed construction, and
- Bridge piers for crossings to meet hydraulic capacity, fisheries and stream morphology requirements.

Environmental Study Report (ESR)

An ESR has been prepared to document the planning and decision making process. The results of the study will be available for review for 30 calendar days starting April 2, 2015 and ending May 4, 2015. It is available for review at the following locations:

Coulter set to carry Pan Am Games torch

Milton native Donna Coulter has been selected to be a Pan Am torchbearer in the Toronto 2015 Pan Am/ Parapan Games.

Coulter was selected through the Ontario Lottery and Gaming (OLG) Corporation's 'Pass it Ontario Program', which gives Ontarians the opportunity to be a Pan Am torchbearer. A previous Milton Citizen of the Year Award winner, Coulter said she couldn't be more excited about the opportunity.

"As a breast cancer survivor, I am starting a new chapter in my life — what an incredible way to begin my journey," she said in a media release. The Milton Chamber of Commerce was invited by the OLG to make the torchbearer selection. Chamber President Lesley Mansfield said Coulter was chosen because she embodies the core characteristics of the torch relay — community, celebration, participation and pride.

"Donna is a champion in our community who signifies the spirit of a Pan Am torchbearer as a dedicated volunteer in the town of Milton over the past 60 years," she said in the release.

Coulter has been heavily involved with United Way Milton, the Milton District Hospital Auxiliary and countless other community causes over the years.

Torchbearers very excited

He views the torch relay as an opportunity to showcase his community.

"It will bring even greater exposure to our wonderful town," he said. "I think people will be impressed with our little gem along the escarpment." Presented by President's Choice and the OLG, the Pan Am Games Torch Relay will run over 41 days and include 3,000 torchbearers covering an average distance of 200 metres.
