don't need them right below a residential subdivision, right below an education village, with no direct access to roads," she said.

CN's intermodal plans have a long history in Milton, first coming forward in 2001.

At that time the company was met with in-

tense opposition from local residents, with then-Halton MP Gary Carr delivering a 6,000name petition to Parliament Hill.

In 2008, CN decided to call off its plans, but still continued to own 1,000 acres of land in south Milton.

The current proposal for a 400-acre intermodal is part of this larger plot of land, which has some residents concerned about the possibility of future expansion.

CN has opened up a project information centre at 61 James Snow Pkwy. for residents to visit and speak with company staff.

The centre is open on Saturdays from 9 a.m. to 2 p.m.
