

Three impaired driving charges laid

Halton police laid three charges related to drinking and driving last week in Milton. Police say they stopped a car they saw leaving the LCBO at Main and Bronte Streets last June 10 around 9 p.m. Antonia Maglio, 44, of Milton was charged with impaired driving and driving with a blood alcohol level of 80 mg per 100 ml of blood. Meanwhile, police saw a car they said was speeding southbound on Bronte Street just after midnight June 10, and pulled it over. Saranya Soundararajan, 22, of Milton was charged with driving with a blood alcohol

level of 80 mg per 100 ml of blood. On June 8 at 9 p.m., OPP were called by numerous drivers heading westbound on Hwy. 401, in Milton. One driver alleges the vehicle nearly sideswiped him, while another driver said it appeared the driver of the vehicle was driving with his eyes closed. A vehicle was seen exiting at James Snow Parkway. Halton police went to the address associated with the vehicle and found the driver heading home. Dale Fitzpatrick, 41, of Milton was charged with driving with a blood alcohol level of 80 mg per 100 ml of blood.

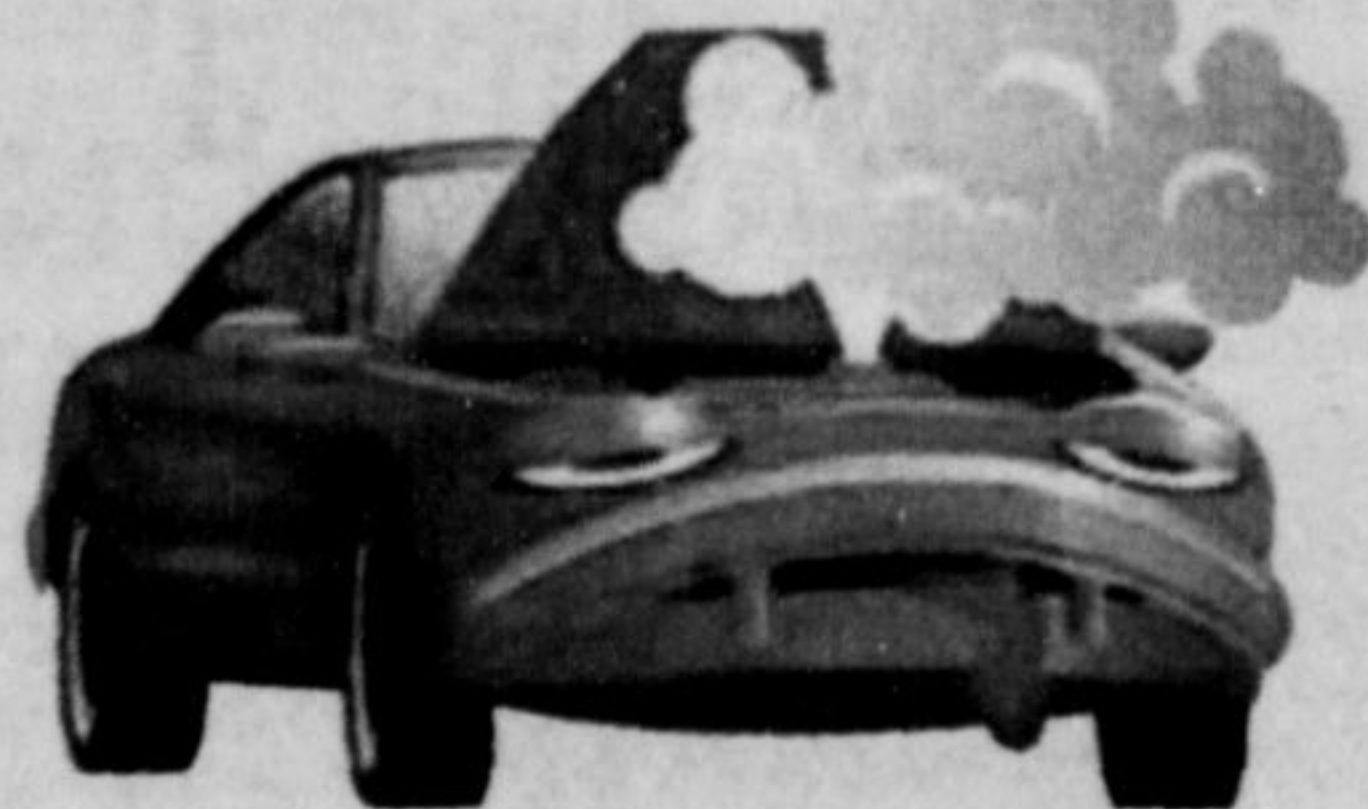
