

## Post-secondary institution 'completes' town: WLU president

paign, Friends of the Milton Education Village and a Laurier for Laurier public campaign, will also be explored in hopes that it will have the same success as Our Home, Our Hospital capital campaign — which helped secure provincial funding for the Milton District Hospital expansion.

"A post-secondary institution completes a city and town in a way that very few pieces of infrastructure can do. This campaign will show the provincial government just how important a university is for this very rapidly growing and wonderful community," said Blouw.

In addition to the public campaign, council is using the remaining \$64,000 in the MEV capital projects budget for the preparation of conceptual designs, renderings and models of the project. Town CAO Bill Mann said the plans right now are conceptual in nature, but when completed, they will be "sexy, sustainable and urbane to get people excited."

Last Monday's council decision comes after the Province debriefed Milton town staff and Laurier as to why the winning submission - York University's new Markham Centre in partnership with Seneca Collage — was considered a more complete proposal. Mann said it seemed like Markham was a "quick fix," as it proposed only one building on a five-acre site servicing 2,000 to 3,000 students, while the 150-acre land gift from the Town of Milton to WLU, valued at \$50 million, would have accommodated 15,000 students.

Blouw said the Ministry of Training, Colleges and Universities identified four areas that were lacking in the initial submission — a college partner, more options for transportation, leveraging of existing infrastructure and
