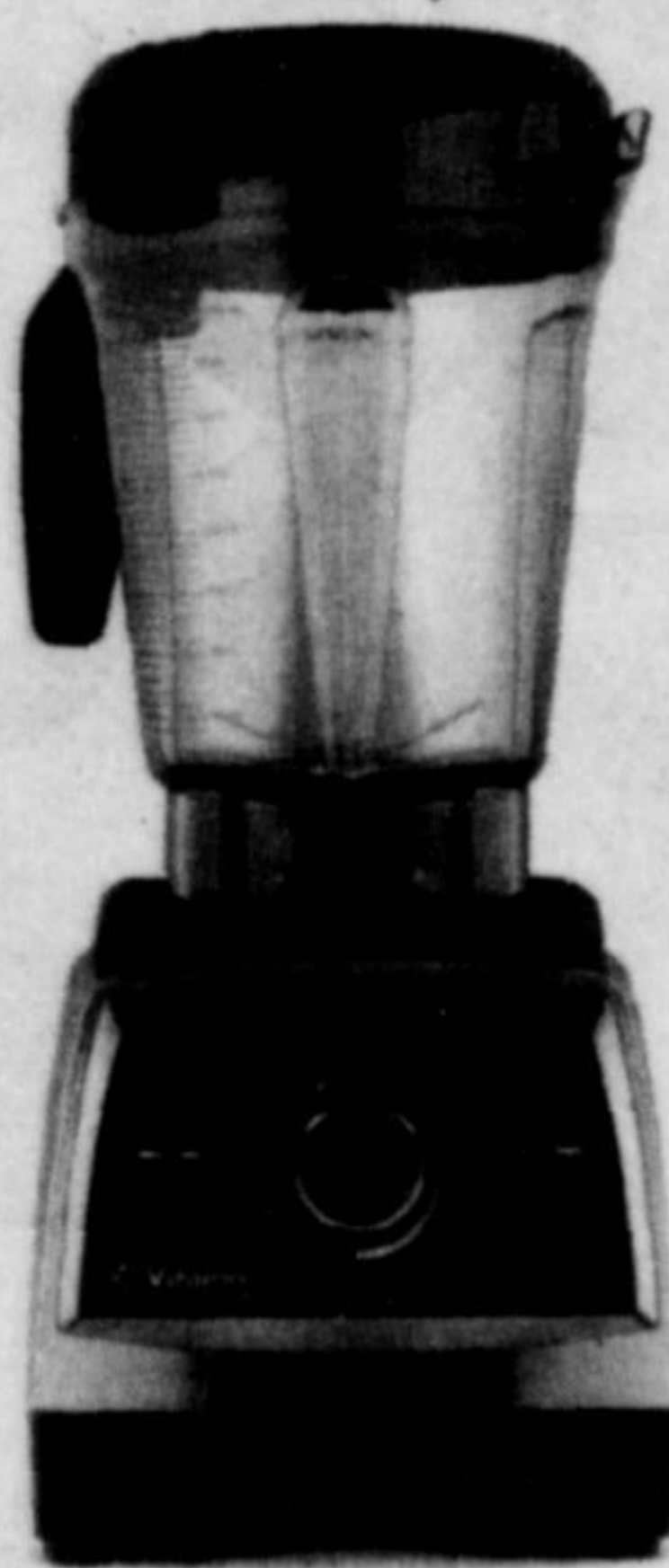

Miltonian cashes in on lottery win

A Milton man is cashing in on more than \$110,000 after playing LOTTO 6/49 on October 17. John Culhane won \$116,915.80 after matching five out of six numbers, plus the bonus number, on his lottery ticket.

The winning ticket was purchased at Fresh Mart on Church Street in Toronto. Since LOTTO 6/49 was launched in 1982, Ontario lottery players have won more than \$10.9 billion in prize money, including 1,314 jackpot wins.
