

Auto dealer allegedly responsible for ID fraud

Two Mississauga men face charges in connection with a police investigation into identity theft involving a local auto dealer.

In October, a victim reported having a motor vehicle registered to him in which he had no knowledge. He became aware of the unauthorized registration as a result of receiving 407 ETR bills.

The Halton Regional Police Service's Fraud Bureau subsequently launched an investigation, in partnership with the Ontario Motor Vehicle Industry Council (OMVIC).

It was discovered, allegedly, that an independent auto dealer in Milton — Incarnet Auto Sales and Leasing on Lawson Road — was responsible for the false registrations.

It was revealed that four other people from the GTA were identified as victims of the same scam.

The location of these falsely registered vehicles is unknown as this time, but Halton police believe one of the vehicles has been involved in a break and enter in southern Ontario. Search warrants were executed at the Milton dealership and residence of the dealership principles, leading to the arrest of two men.

Jan Kowalczyk, 59, faces six counts of identity fraud and six counts of uttering forged documents. Justin Kowalczyk, 25, is charged with five counts of identity fraud and five counts of uttering forged documents. Police and the OMVIC have seen a growing trend in the false registration of vehicles for fraudulent gain.
