

IN THE COURT OF QUEEN'S BENCH AND COURTS PLEAS.
Regale General's
Easter Term,
29th Victoria.

It is ordered as follows:—
1. One of the Judges of the Superior Courts of Common Law shall sit in open court each week in Osgoode Hall, pursuant to the Administration of Justice Act, 1874, for the hearing and disposing of such matters as the transaction of such business as may be heard, disposed of, and transacted by a single Judge.

2. There shall be no such sitting any time between the first day of April and the 21st day of August, both days inclusive, and between the 22nd day of December and the 1st day of February thereafter, both days inclusive.

3. The Judge shall sit on Tuesdays at 1 o'clock, at the hour of 12 o'clock noon, but on such other day and days as at such other hours or times as the Judge for the time being shall direct. This arrangement is to give the power of the Judge, if he see fit, to sit only on one day in each week sufficient for the disposal of business.

4. The Judge may fix any time during the session of the Court of Queen's Bench for the hearing of cases, and from time to time shall be free to do so at any time, day or days, to find necessary for the disposal of business.

5. The Judge sitting as aforesaid shall either before, during, or after such sitting, as the Judge may appoint, dispose of all such business in Chambers as can be disposed of, and may receive the Report of the Clerk of the Court of Queen's Bench and Peas of the Clerk of Queen's Bench in Chambers, shall be left with the Clerk of the Court for the time being, on a day not later than two clear days before the day on which the same are to be heard, to whom they say, not later than Friday for Friday, and not later than Saturday for Saturday.

6. All rules, dismisers, special cases, appears, or other matters intended to be argued before the Judge shall be served on the party to whom the particular cause for hearing or disposal thereof was referred by the Clerk of the Court on a list, one copy of which shall be delivered by the Clerk to the Judge, and another posted up outside the Court room.

7. All rules, dismisers, special cases, appear, and other matters entered on and disposed of in the order in which the same are entered on the list, unless the judge otherwise order.

8. The first business of each sitting shall be motions, and, in motions before the full court, in which the cause is the last in the order in which they are entered, unless otherwise ordered by the judge.

9. Any party desiring the rule, order, or decision of the judge in either cause, and re-hearing, in the full court, in which the cause or matter is pending, shall give notice in writing to that effect to the opposite party within two weeks next after the day on which the rule, order or decision shall have been granted, made, or pronounced.

10. All rules, dismisers, special cases, appear, and other matters entered on and disposed of in the order in which the same are entered on the list, unless the judge otherwise order.

11. Any party, business of each sitting shall be motions, and, in motions before the full court, in which the cause is the last in the order in which they are entered, unless otherwise ordered by the judge.

12. Any party desiring the rule, order, or decision of the judge in either cause, and re-hearing, in the full court, in which the cause or matter is pending, shall give notice in writing to that effect to the opposite party within two weeks next after the day on which the rule, order or decision shall have been granted, made, or pronounced.

13. Any party, business of each sitting shall be motions, and, in motions before the full court, in which the cause is the last in the order in which they are entered, unless otherwise ordered by the judge.

14. Except for the case of the weekly Sunday edition extra: \$1.25 per year. We have no travelling expenses.

15. If the review or rehearing be proceeded with within the period of two weeks next after the day of the granting, making or pronouncing of the rule, order or decision with which the party is dissatisfied, it shall be set down to be reviewed and reheard at least two clear days before the day on which the same is to be argued.

16. The cause or matter to be reviewed and reheard shall be set down to be heard on the day of the "Paper Days" during the same or on such other date as determined by the full Court, to be appointed for the purpose, the same shall be set down to be reviewed and reheard at least two clear days before the day on which the same is to be argued.

17. 18. No petition, rule or order shall be necessary for the purpose of review or rehearing either of the Superior Courts or of the Court of Queen's Bench.

19. On a review or rehearing the party setting down the cause or matter for review or rehearing shall have the right to begin or reply, unless otherwise ordered by the Court.

20. In the case of the foregoing rules contained, shall be held or taken in any manner to deprive any party of the right to have a cause or matter reviewed or heard where the right is conferred by statute, but only to speed the course of proceeding with a view to such review and rehearing.

21. Nothing in the said rules contained shall be held or taken in any manner to interfere with the power of the Court or the Judge in their or his discretion; for good cause, to regard any particular cause, to dispense with any or all of the said rules.

22. The rules of Trinity Term, 28th Vic., for a prorogation on the 5th September, 1874, shall be rescinded, on, from, and after the day these rules shall take effect.
