LEGAL INTELLIGENCE.

COURT OF CHANCERY. A Newspaper Publisher up for Contempt. THIRD DAY. Mr. C. H. Mackintosh, publisher of the Ottawa Citizen, was yesterday brought before His Lordship the Vice-Chancellor, for contempt of court having published in that journal a synopsis of the bill of complaint filed in the case of Donnelly vs. Mass and Fraser, which was a contempt of court having a tendency to prejudice the case and to affect the character and social standing of a party to the suit. Mr. Fitzgerald, who was the publisher of the London Pall Mall Gazette was committed for publishing abstracts from affidavits in the Tichborne litigation while the case was being investigated. His Lordship expressed the opinion that the libel was published without any intention to do wrong, although the act was itself improper and unjustifiable, and deserving of censure.

Mr. O'Connor, Q.C., on behalf of the publisher, contended, since the case was not before a jury, was not to be prejudiced by the publication, but he admitted the abstract principle that the Court could admit for contempt if His Lordship thought any improper influence was exerted. The Toronto Globe published a synopsis of the pleadings in the Mercer vs. Case in advance, and no prosecution for contempt arose in consequence.

Mr. Fitzgerald pleaded that there was no animus in the publication of the article upon which a motion for his commitment had been granted. The report as published was handed to him by one of the staff, with an intimation that another newspaper would contain a similar synopsis of the bill. As both issued simultaneously, the reporter complained of his being so treated, however, with any design, direct or indirect, of injuring the defendant, Mrs. Maria Burke Masse, a lady unknown to him, and a lady of unimpeachable character, for aught he knew. In fact so ignorant was he regarding details that at the time he was not aware whether the case had been before the court or not.

His Lordship said that after hearing Mr. Mackintosh's statement, he presumed that Mr. Fitzgerald would not press the matter.

Mr. Fitzgerald intimated his willingness that the matter should drop, but thought the defendant was entitled to costs of motion.

His Lordship said he did not think the publication of the matter pending, but not directly before the court, justifiable with or without jury. At least this is the law as it stands at present. In former times the law was so strict that the publication of details before a court was not permissible. Happily it has been greatly modified. One could not always tell what influence such a report would have on witnesses, as read by Mr. Fitzgerald it might be construed as injurious to the defendant, but after Mr. Mackintosh's explanation he was satisfied there was no intent with design to injure any one. He would therefore discharge the motion, but would have to allow costs thereof.

Hon. Mr. O'Connor moved for an order to commit C. W. Mitchell, proprietor of the Free Press, for contempt of court in publishing the allegations with comments thereon.

The rest of the day was occupied with the evidence in the case.

His Lordship said that after hearing Mr. Mackintosh's statement, he presumed that Mr. Fitzgerald would not press the matter.

Mr. Fitzgerald intimated his willingness that the matter should drop, but thought the defendant was entitled to costs of motion.

His Lordship said he did not think the publication of the matter pending, but not directly before the court, justifiable with or without jury. At least this is the law as it stands at present. In former times the law was so strict that the publication of details before a court was not permissible. Happily it has been greatly modified. One could not always tell what influence such a report would have on witnesses, as read by Mr. Fitzgerald it might be construed as injurious to the defendant, but after Mr. Mackintosh's explanation he was satisfied there was no intent with design to injure any one. He would therefore discharge the motion, but would have to allow costs thereof.

Hon. Mr. O'Connor moved for an order to commit C. W. Mitchell, proprietor of the Free Press, for contempt of court in publishing the allegations with comments thereon.

The rest of the day was occupied with the evidence in the case.
