# New law(s) off to a good start, but...

Property NEW THE Trespass and Occupier's Liability Acts which came into effect Sept. 8, 1980, are much needed legislation but the new law fails to complete the task it was designed for.

The major reason for implimenting the new law was to clarify the many ambiguities and points of confusion that existed under the old legislation.

Further, the new acts were to increase protection for landowners rights as well as placing some responsibility on him and land users for the protection of anyone using the land for recreation.

But the new legislation, even though it has gone a long way to improving the former act has its own ambiguities that tend to defeat the purpose of clarification.

For example, the basis of the occupier's liability section is seen in section 3-(1), (2), which says the occupier has a duty to take such care, (for users safety), as is in all cases reasonable. The key word is "reasonable"

The word itself requires on interpretation.

After all, what is reasonable for one person is not necessarily reasonable for another.

What is reasonable precaution for another's safety?

Does it mean merely a verbal warning of possible danger areas or does it mean backfilling every gopher hole in sight so as to prevent an accident?

No doubt trespassers should be dealt with and arrested if need be, but to place such authority or power in the hands of private citizens is at least a questionable decision; particularly considering that many trespass incidents occur during hunting season when those involved are likely to be armed.

The new legislation was meant to clarify and facilitate enforcement and the processing of cases under-the

The built-in ambiguities and potential for violent confrontation between landowners and trespassers that arise from the new legislation may serve to complicate matters rather than simplify them.


