

## on tonight's council agenda Penetanguishene council meets tonight in

the council chamber in the municipal building on Robert Street West at 7:30 p.m.

Council will receive correspondence concerning an application for a liquor licence for the Georgian Queen.

Correspondence referred to committee includes letters from Minister of Housing Claude Bennett dealing with requests from Tiny Township and Tay Township to withdraw from the Tiny-Tay Peninsula Planning Area. Council will also receive a letter to the minister on the same subject from Tay Township Reeve Charles Rawson.

Other correspondence referred to committee to be received by council tonight concerns an application from the Commodore Hotel to the Liquor Licence Board of Ontario to have the hotel's classification changed to tavern from hotel.

Council will also receive a letter from the town planner commenting on the hotel's application from the perspective of the town's zoning bylaws.

One bylaw on the agenda is a bylaw to authorize the borrowing by the town of \$1.5 million.

# Cowan leads Kings to 7-2 win

Penetanguishene Kings Junior C hockey club had a very successful night Friday in Huntsville against the Huskies as they defeated Huskies 7-2.

The game was relatively clean with Penetanguishene getting only four minor penalties for a total of eight minutes in penalties.

Carl Cowan was the driving force behind the Kings' attack as he tallied up four goals and two assists.

Cowan scored his first goal in the first period on a powerplay with Terry Pilon getting a goal for the Kings as well in that period.

Huntsville also scored in the first period, the score 2-1 at the end of the first 20 minutes of play. Cowan scored again for Penetanguishene in the second period, once more on a power play.

#### Jury hands down its verdict

A former Elmvale resident, Barry James Stevens, 43, of Wasaga Beach was convicted of murder Friday in Barrie Supreme Court following a nine-day trial.

He was sentenced to life imprisonment with no chance for parole for 25 years.

The trial stemmed from the death of 25year-old Gwendolyn Fletcher of Collingwood whose body was discovered in a wooden area in Flos Township in 1978.
