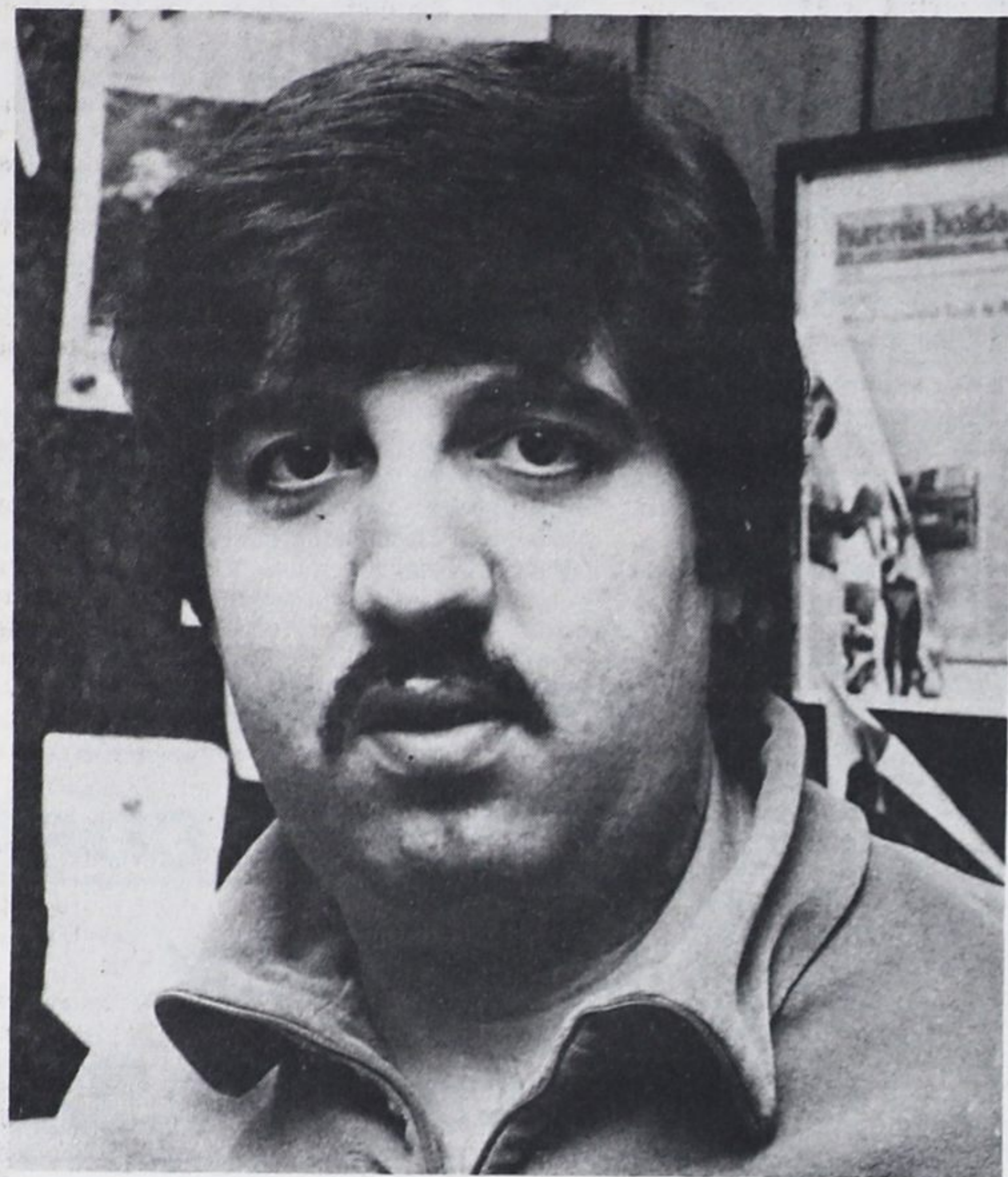


# That's My Line



## Nick Boudouris *Food with a view*

Nick Boudouris has owned the popular Dock Lunch at the Penetanguishene Town Dock for five years. He has big plans for the coming, and next few, years.

The people here have been very good to me. When I chose to move here, to open a business, to live with my family, a big factor was that the people are so nice here. I want to do something for them that will benefit the whole area.

This year's Bikini Contest will be only part of a special weekend, I'm planning. I'm arranging for a baseball tournament. The 15 top ladies baseball teams in Ontario will be competing for a big prize.

There will be a dance, and a marathon swimming race across the bay, in addition to an expanded bikini contest. Last year's contest was held to choose Miss Bikini. This year there will be a Mr. Bikini contest as well.

On the night of the dance one of the two winners will receive a top prize: two airline

tickets and an expense-free week's vacation to someplace like Acapulco.

My location here on the bay, next to the water, with the view, is one of the best of its kind in the country. I'm working on a long-term project that will in three or four years ensure that everyone in the country knows this waterfront.

Running this place is a seven day a week occupation. I'm not necessarily here day and night, but the business demands that I be constantly around. I have a very capable staff, and so I have time for my family, but I have to be here after hours to do inventory and handle the cash, for example. I work long hours seven days a week.

I like sports. I was very active and did a bit of everything. If I was going to be something else, I'd be a hockey player.

Someday I'd like to be the coach of the Toronto Maple Leafs and take the team to a Stanley Cup victory. (laughs) There are 27 people on

the payroll, eight of them full-time employees, and the rest part-time.

Because this is a tourist area, a lot of people come here to visit in the summer. I holiday myself every year, and on my holidays I've run into people I've met here. The first time I went to the Bahamas I saw some people from the U.S. that I knew here in Penetanguishene. The same thing happened when I was in Acapulco.

That's how I got the idea of putting World Famous in front of Dock Lunch on my signs. The signs in the town arena and the billboards that you see were my idea.

My brother and I moved here from Toronto in 1973 after we had visited here and got to know some people. I lived in Toronto between 1964 and 1973, after emigrating from Athens, Greece. My brother and I bought the Watergate Restaurant, and I bought the Dock Lunch after we sold the Watergate.

# Target of over 300 items set for Rotary auction

Midland and area merchants should brace themselves.

The third annual Midland Rotary Club TV-radio auction is set for Feb. 16 and the Rotarians want to have over 300 items to auction

by then.

Rotary President Don McNee points out that previous auctions have been the highest rated programs of the year for local radio and cable television, and that the publicity value

to contributors is considerable.

Last year's radio auction raised \$8,000 for the Rotarians. In recent years the Rotary Club of Midland has donated \$15,000 to the Midland YMCA \$10,000 to

Huron District Hospital, \$3,000 to the Midland Arena, and smaller amounts to Penetanguishene General Hospital, the Salvation Army, a Boat People fund, and Penetanguishene's Huronia Developmental Nursery and Centre.

The auction will be live between 6:30 p.m. and 12 p.m. on both local radio and cable television.

Major items auctioned in other auctions have been cars, trucks and snowblowers. Unusual items sold to the public have included an airplane flight over the area and a ride on Georgian Bay with the Midland OPP.

## Platt offers his own formula

In recent months Midland's Alderman Richard Platt has become the most vocal when it has come to registering his opposition to the manner in which building permits have been issued by the Township of Tiny for further commercial development along Highway 27 just west of Midland town limits.

The alderman has, for instance, long advocated a cost-sharing program whereby both municipalities share in the maintenance of Hugel Avenue which feeds from Midland out into the township to the plazas and malls there.

Platt has noted on more than one occasion even though the town doesn't not derive any direct benefit from these enterprises vehicular traffic to and from these facilities use town streets which over the years take a beating.

**Developments**  
The alderman, an active member of Midland council, Midland Planning Board and the Tiny-Tay Peninsula Planning

Board, has prepared a lengthy resolution which would call upon major developments in the township, west of Midland, not to proceed with any further development without benefit of piped storm drainage or piped sanitary sewers or other hard services.

Platt's motion which is to go the Midland Planning Board before council considers it, also stresses the town "express these concerns to the developers (of this commercial expansion) to the Township of Tiny and to the Ministry of Intergovernmental Affairs and further declare its intentions once the Municipal Boundaries Negotiations Act has been enacted to apply to the Ministry of Intergovernmental Affairs for negotiations to be initiated towards joint servicing agreement between the town and the township in regard to this proposed development."

The development Platt refers to is a 60-store small complex which is to be con-

structed starting later this year on the west side of Highway 27 at Hugel Avenue in Tiny Township.

**Annexation**  
Previously the alderman has not been shy in also suggesting sometime in the future Town of Midland might consider annexation of certain lands west of the town.
