their case. Port McNicoll would be a suitable site for the convention centre. According to Reeve Moreau, "We have all the necessary facilities to accommodate the hotel. We have room on Paradise Point Road. There are several small local marinas, and I believe it will be possible to service the

development." Port McNicoll will make an effort to acquire the 600-unit motel convention centre because, as Reeve Moreau puts it, "We can certainly accommodate the centre, and it would put us on the map. This type of development would pick us right up and could do nothing but upgrade the village."


