# Town of Penetanguishene 1980 Financial highlights

The Local Boards and Municipal Enterprise not consolidated are as follows: - Penetanguishene Water & Light Commission; Penetanguishene Arena, Parks and Recreation Board; Industrial Commission; Penetanguishene Public Library Board; Penetanguishene Museum Board; Penetanguishene Planning Board; and the joint local Board - Midland-Penetanguishene-Tiny Sanitary Landfill Committee.
- (2) The enterprise of the Town whose revenues and expenditures has not been consolidated in the 1980 Financial Report is the Penetanguishene Water & Light Commission.
- (3) The above data have been extracted from the audited 1980 Financial Report of the Town and its local boards as described in Note 1.
