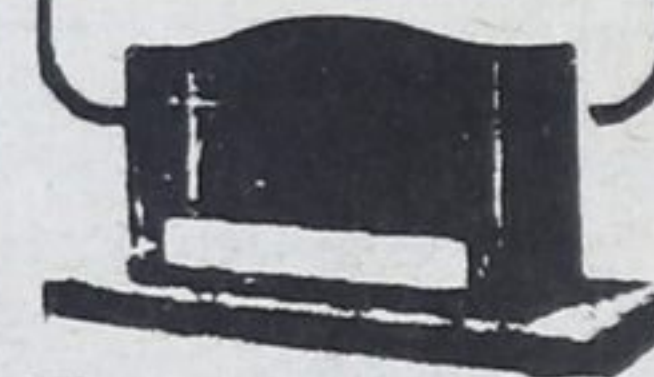

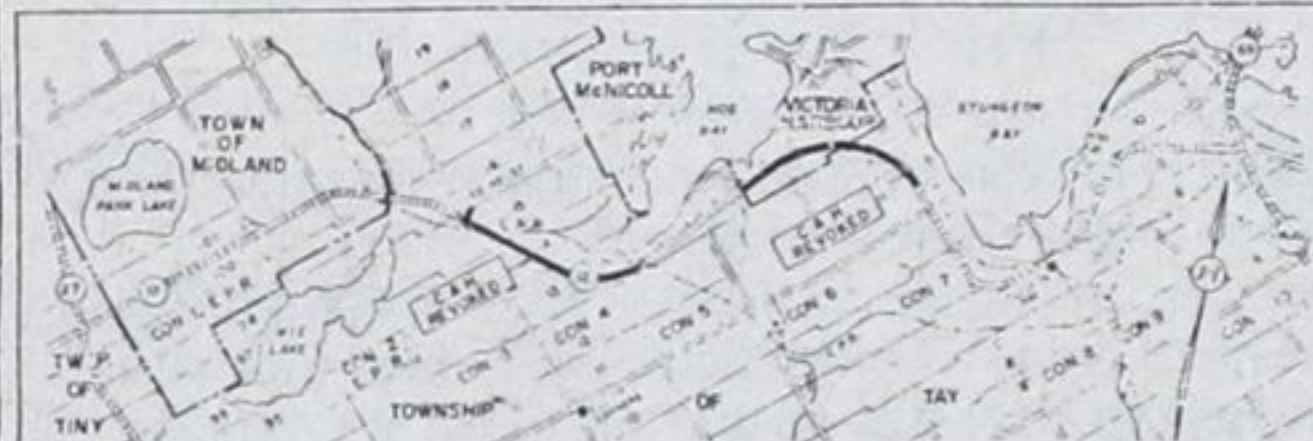
THE PUBLIC TRANSPORTATION AND HIGHWAY IMPROVEMENT ACT PUBLIC NOTICE

IS HEREBY GIVEN that, pursuant to Section 5 of the Public Transportation and Highway Improvement Act. (R.S.O. 1970, chap. 201 and amendments thereto), the Lieutenant Governor in Council did designate a portion of Highway 12 from Highway 400 westerly to the Town of Midland as the King's Highway and did revoke the controlled access highway designation of short bypasses at Port McNicoll and at Victoria Harbour. The effective date of the designation as the King's Highway and the revocation of the controlled access highway designation was the 14th day of May, 1981.

The portions of highway from which controlled access highway designation is removed are located in:

1. Township of Tay
Part of Lots 13, 14 and 15, Concession 4; Part of Lot 13, Concession 5; and Part of Lots 11 and 12, Concession 7;
2. Village of Victoria Harbour
Part of Lot 13, Concession 6; Part of Block "E", Registered Plan 1340; Part of Lots 10 to 22, Registered Plan 470; Part of Lots 11 and 12, West side of West Street and Part of Lot 13, East Side of Newton Street, Registered Plan 496; and Part of Block "B", Registered Plan 459;
