## Night-hunting deer

# MNR presses charges after carcasses discovered

Rules were made to be broken, and to some hunters, it follows that deer were made to be shot—anytime, anywhere, anyhow.

Ministry of Natural Resources conservation officers laid 14 charges—ranging from hunting deer during a closed season, to possession of deer during closed season, to night-hunting—against at least six hunters in the MNR's Huronia District as of last Friday.

And, though open season for deer hunting with bows opened in the district on Monday, officials don't expect the infractions against hunting regulations to drop off too readily.

"It's terrible," said Pat Hogan, Huronia District Conservation Officers, Co-ordinator. "We just get sick and tired of these guys year after year after year."

Hogan has only eight officers and a selection of deputies from outdoors clubs to with which to patrol the area—which extends from Dufferin County through Simcoe into the Muskokas.

Three men from the New Lowell area appeared in Barrie Provincial Court, Friday and three more are to appear in Alliston Provincial Court tomorrow. The first three, who were charged in late September and early October, had their case remanded to

Oct. 30.

Conservation officers have seized one four-wheel drive vehicle, one car, two rifles, four deer carcasses and parts of deer—which officials believe to be from three more deer—from a freezer.

Maximum fine for the violations is \$5,000.

All six men have been charged with hunting deer during closed season and with night-hunting.

Open season for deer hunting with bows runs to Dec. 13, but the season allowing rifles, shotguns, and muzzle-loaders runs only from Nov. 2 to Nov. 5. Monday to Saturday hours include one-half hour before sunrise to one-

half-hour after sunset.

Night hunting is the practise of shining a beam of light through the darkened woods, which, if aimed at a deer, tends to mesmerize the animal long enough to make the kill.

Hogan says it's tough for he and his patrollers to cover such a wide area and asks the aid of all hunters in reporting immediately any activity which may indicate violations of the regulations.

He says anyone spotting trouble may call the MNR Huronia District Office in Midhurst 24 hours a day toll free at Zenith 73000—or simply contact your local Ontario Provincial Police office.
