Safe driving campaign revealed

Dear Editor:

Solicitor General George Taylor and Ontario Provincial Police Commissioner James Erskine today revealed a program designed to make Ontario highways safer over the holiday period and keep drinking drivers off the road.

Both Mr. Taylor and Commissioner Erskine, who is also chairman of the Ontario Traffic Safety Council, emphasized that police would be doing their utmost to get drinking drivers off the road.

One of the methods will be by enforcing the temporary suspension law-which requires marginally impaired drivers to surrender their licences to police for 12 hours if it is so indicated by a portable breathalyzer known as an Alert device.

The Solicitor General told a news conference that through the Ontario Police Commission he is urging all Ontario police forces to join in the Christmas and New Year's safety campaign, using such methods as the temporary suspension program, spot checks and enforcement of the seat belt laws.

"The temporary suspension law, enacted by the legislature last year, is proving to be one of the most effective instruments the police have in combatting the drinking-driving problem," Mr. Taylor said.

Mr. Taylor also said the ministry and the O.P.P. were co-operating with the P.R.I.D.E. organization in getting their message to the public of the tragedies caused by drinking and driving.

The Minister said the O.P.P. has tape cassettes with messages from P.R.I.D.E. members which will be distributed to radio stations across the province by community services officers.

Balanced viewpoint proposed

Dear Editor:

In his Christmas newsletter, our M.P., Ron Stewart, poses a question on the cruise nuclear missile, in simplistic terms: "Should Canada honour its NATO pledge by allowing cruise missile testing here?"

Ron's constituents should be made aware that Canada is NOT obliged to help test the cruise missile as part of this country's contribution to NATO.

The air-launched cruise missile is NOT planned as part of the NATO arsenal; it is part of the U.S. independent strategic arsenal.

The ground-launched cruise missile, which is planned for deployment in Europe, will be assigned to NATO; however, Canada has already committed itself to a non-nuclear role in NATO, and, just as European countries such as The Netherlands and Belgium have no prior com-

mitment to NATO to accept cruise missiles on their soil, Canada has no prior commitment that

requires it to test these weapons. For a balanced viewpoint on this matter, may I recommend the Minority Feport, "Security and Disarmament," issued by distinguished M.P.'s of all three political parties who were members of the House of Commons Standing Committee on External Affairs and National Defense. It was issued in April 1982, and you may obtain a copy by writing to Joe Clark, Pierre Trudeau or Ed Broadbent; no charge—no postage!

The Minority Report stresses Canada's obligation to humanity not to allow tests of this missile "which is patently attack-oriented. By denying the tests, we are protesting against the arms race. By allowing the tests, we aid the arms race. Who will take Canada's words at the U.N. seriously if our acts are the opposite?"
