Tour boat operators will bid for space under proposed bylaw

Midland town council on Monday evening approved in principle a bylaw which covers the berthing of tour boats at the town dock.

The proposed bylaw, to be introduced at the council's next meeting, on Oct. 28, includes a direction that tour boat operators will bid for the berth they want.

Earlier in the day, in Toronto, the case of local tour boat operator Tom Gostick vs. Midland was not heard, as scheduled, in the Supreme Court of Ontario. This was the second time the case was supposed to be heard.

On Monday the two parties were told, outside the court by a

bailiff, that the judge's docket was full. A new hearing date, next April, has been set.

Town solicitor Douglas Haig and Gostick and his legal representatives discussed a settlement, at Haig's invitation. Gostick is meeting with his lawyer on Saturday.

Town clerk Fred Flood says that the proposed bylaw includes a system of tendering for space, and safeguards to avoid the problems that arose at the town dock this past summer.

The bylaw will set the rules so that conflict can be avoided, he says. The harbour committee will be given "teeth" to impose its conditions.

ourselves." Alderman Ross' response was that he didn't see anything wrong with Midland and Tiny Township discussing the town's desire to annex the township's commercial strip.
