THE SIMCOE COUNTY ROMAN CATHOLIC SEPARATE SCHOOL BOARD TAKE NOTICE THAT

The Simcoe County Roman Catholic Separate School Board on the 7th day of August, 1985 passed By-law Number 1701-85 to authorize the borrowing of money by the issue and sale of debentures of the said Board in the principal amount of \$675,000.

1. The purpose for which the money is to be borrowed is to construct school buildings and purchase furniture and equipment for Ecole St. Louis, Dufferin Street, Penetanguishene; St. Joseph's School, Cundles Road East, Barrie; St. Mary's School, Findlay Drive and George Street, Collingwood; and the purchase of a site and initial construction of a building for a school in the Township of Innisfil.

2. The amount to be borrowed is \$675,000 for 10 years on the security of the said debentures, which shall be a charge upon the school-house property and premises and any other real or personal property vested in the said Board and upon the separate school rates collectible by the said Board.

3. The debentures are to be dated the 3rd day of September, 1985 and shall be payable in ten annual instalments of principal on the 3rd day of September in each of the years 1986 to 1995, both inclusive, and shall bear interest payable semi-annually on March 3 and September 3 in each year. The debentures shall bear interest at the rate 11-1/8 percent per annum. The amount payable annually for principal and interest shall be in approximately equal amounts of about \$115,215 for the years 1986 to 1995 inclusive.
