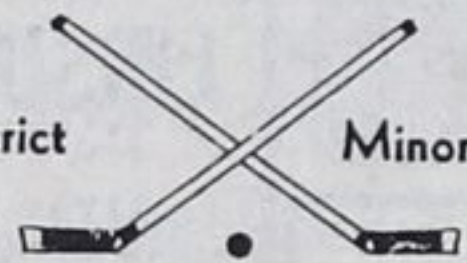

Servicing of clinic headache for doctors

Midland's doctors who want to build a clinic in Tiny Township are stuck in a Catch-22 situation.

The doctors have asked Midland council to let them make an agreement with the town that would allow the doctors' clinic to be connected to the town's water and sewage systems. The town says that the doctors should make their application for servicing to the township, and that if it wished the township could negotiate an arrangement with the town for the doctors.

Yesterday Tiny Township Reeve Morris Darby said that the township

won't be asking the town to let the doctors' clinic be connected to the town's system. The township won't stand in the way of the doctors making their own arrangement with the town, but if they don't come to an agreement with the town, they will have to meet the township's servicing requirements.

Builders in the township provide their own services, and meet the requirements of the responsible ministries, the reeve said.

To date, discussion of the doctors' clinic by Midland council at council meetings has been critical.
