





EXPLANATORY NOTE TO BY LAW NO. 1985-96 Recently the Town of Penetanguishene passed By-law No. 1985-96 which amends Zoning By-law 1975-20. By-law 1985-96 is a "housekeeping" amendment because it makes changes to the text of the overall zoning by-law which are needed for clarity and to avoid confusion. The amendment defines some existing terms used in the by-law and deletes some sections which are no longer necessary.

With one exception involving municipally-owned lands, By-law 1985-96 is not "site specific" in nature because it does not refer to a specific property, but rather to the zoning by-law for the town as a whole. Consequently no key map is included.

The above is a brief explanation of By-law 1985-96. For further elaboration, please contact the Planning Administrator at the Penetanguishene Municipal Offices.
