One of the complainants' witnesses, Moreland Lynn, described Ogilvie, Mudry reminded the jury, as "a reptile, a Marxist, a Communist, an anarchist," someone who tries to overthrow the government. Ogilvie's response was to call the former mayor of Midland, Mare Lynn, Mudry said.

Mudry said his client is careful, thorough, and of good memory. He is obsessed with politics. "It is consistent with honesty to be critical," Mudry told the jury. He suggested to the jury that the lawyers' lawsuit was more an attempt to stop Ogilvie from asking questions and "keep a profitable situation going" and less about malice by Ogilvie.




