

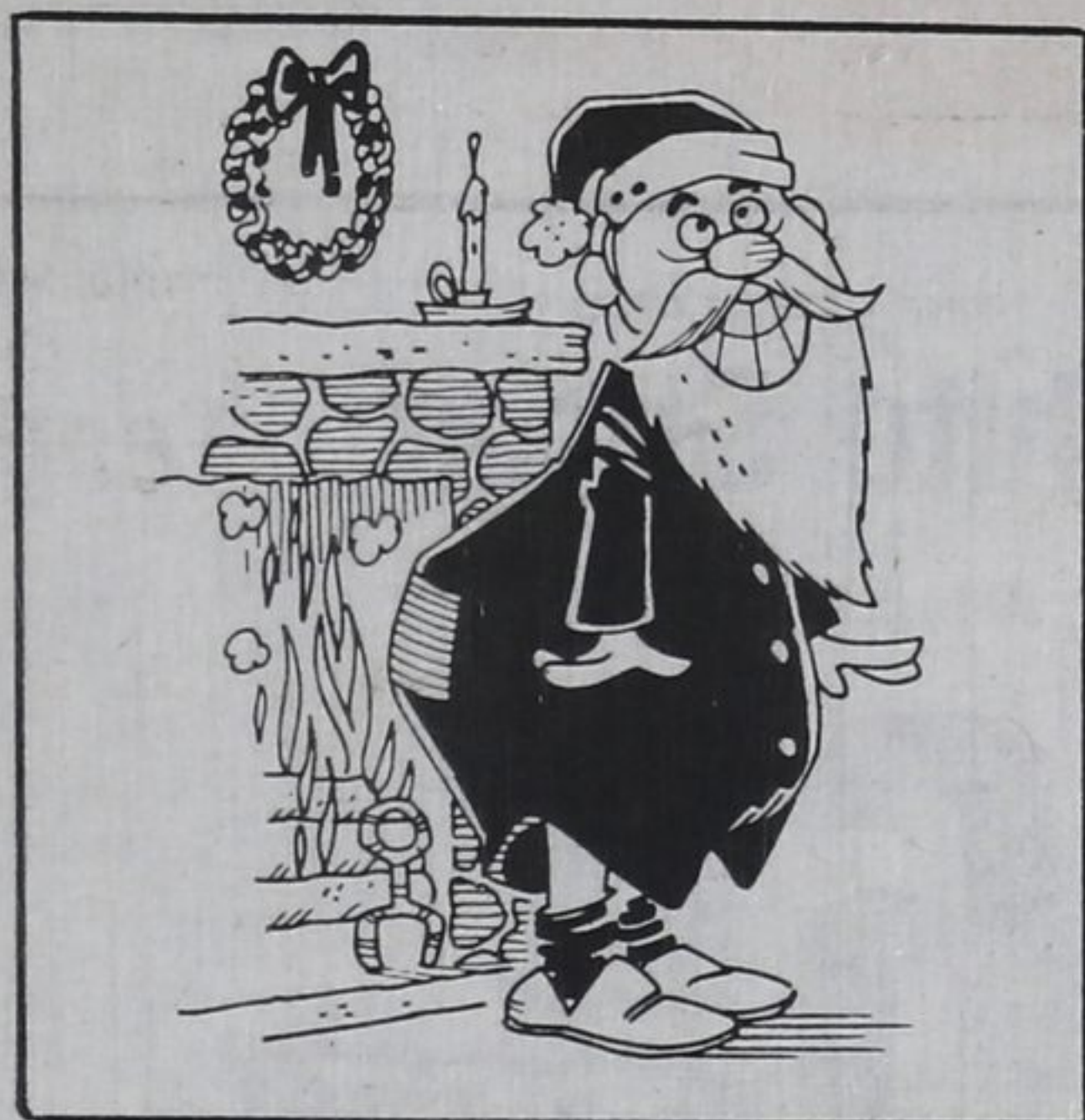

Preliminary draft proposals, plainly marked as to contents and addressed to the undersigned, will be received up to 4:00 p.m. E.D.S.T. Monday, December 1, 1986 for the construction of single family residential units in the following locations on builder owned lots:

- Village of Coldwater - 1 unit
- Orillia Twsp - 1 unit
- Village of Victoria Harbour - 1 unit
- Tiny Twsp - 2 units
- Village of Waubaushene - 1 unit
- Tay Twsp - 2 units

- All preliminary proposals must contain:
- a) Design sketches or actual blue prints of the proposed unit
 - b) List of items which make up the major components of the unit: ie. heating & electrical system, insulation levels, etc.
 - c) Type of servicing provided to the unit: ie. septic/sewer
 - d) Legal description of the proposed building lot and its dimensions
 - e) Total fixed price for the unit, 100% complete
- All proposals must incorporate the following for new construction:
- low maintenance materials
 - awareness of window placements (minimal north facing)
 - wood chutes where dual purpose heating sources are proposed - all furnaces to have dual speed fan systems
 - humidistat controlled air ventilation
 - insulation levels governed by degree days

Submitted unit types will be carefully reviewed & selected by CMHC to suit owner needs, the site and the community as a whole. The proposed unit for construction must have three bedrooms, a full basement and shall be no more than 97.5m² or no less than 92.9m². Electric baseboard heating will not be accepted. Careful attention must be paid to exterior finishes and siting to ensure conformity with the adjacent units.

All proposals submitted within the prescribed guidelines will be reviewed. No proposal necessarily accepted.
