PUBLIC MEETING.

According to announcement in our issue
of last week, a meeting of the ratepay-
ers of Richmond Hill was held in the
Council chamber on Friday evening, Feb.
29th for the purpose of taking into con-
sideration the building of a town Hall.
There were about fifty persons present.
On motion Mr. H. A. Nicholls acted as
Secretary.

The Reeve, Mr. J. Brown, opened the
meeting by saying he had called them to-
gether at the request of several ratepay-
ers, and, although he did not wish to in-
fluence them in the matter, thought if
they ever intended building a town Hall,
now was the time to set to work. He
thought a Hall could be built suitable for
the village for about \$4000. Would pro-
pose to extend the time of payment say
10 years. The Central Bank was going
to open a branch here, and he had reason
to believe, that by building a bank in
connection with the hall, we could rent
the same for \$200 per annum. Cost of
caretaking, ringing bell, &c., would not
cost much more than at present. We
have been incorporated for ten or eleven
years and with the exception of fire ap-
paratus, and sidewalks, very little could
be seen in the way of public improve-
ment.

Mr. I. Crosby, as a member of the
Council, said he would like more infor-
mation on the subject. In answer to a
question, the reeve said the land might
cost \$1,000. Mr. Crosby thought such
buildings generally go to about 50 per
cent. above the estimate, and as a vault
—Burglar proof—would have to be built
in connection with bank, he thought to
extend payment over ten years, the amount
required the first year would not be less
than \$800, and last year \$530, which
at present would be a heavy undertaking.

Mr. Harrison being called upon, said,
the building of a hall was optional with
us, but the time was not far distant when
we would be compelled to provide more
suitable school accommodation, and
thought it would be well to provide for
that which was absolutely necessary.

Mr. J. K. Falconbridge fully agreed
with Messrs. Crosby and Harrison in
their remarks; instead of six or seven
hundred we might count on not less than
\$1,000 for the first instalment. He con-
sidered we had ample accommodation for
political and other public meetings, and,
at present would go entirely against it.

Mr. Teeffy, being called upon, said he
had come to hear those who were in favor
of building.
Mr. Brown said he had been requested
by several to call this meeting, to discuss
the subject, but they had failed to put in
an appearance.

Mr. B. Redditt said he was one who
had asked the Reeve to call a meeting.
The building of a hall was not a new
thing, as it was discussed three years ago.
He was in sympathy with the Reeve and
thought something should be done. When
Council-chamber and engine-room were
rented from Mr. Palmer, some grumbled
about paying \$60 per year, but had now
turned around. "Ratepayer" in village
papers, was mis-leading, as frontage tax,
and fire apparatus, would not appear in
future accounts. Was in favor of paying
more attention to public and less to High
School, said we had been threatened with
building schools for sixteen years and
nothing had yet been done. The present
fire hall was not suitable, the engine now
being greatly damaged by taking it out
hurriedly, as the bridge was too steep
from the sidewalk.

Mr. Pugsley said he expected to hear a
better discussion, the speakers had not
presented the case fairly, they had spoken
of the expense, without making refer-
ence to the revenue which might be de-
rived therefrom. He was willing to fall
in with the majority, but was in sym-
pathy with the Reeve and Mr. Redditt
in building a town hall, engine-room,
lockup, and all combined. Aurora and
Newmarket could speak of a town hall as
their own, and we should not be behind
them in that respect.

Mr. Arnold would favor a Village
cemetery rather than a town hall.

Mr. Moodie was not in favor of it.
Masonic hall did not pay, did not think
building at present would be a good in-
vestment.

Mr. Pugsley moved, seconded by Mr.
Crosby that the discussion close. Carried
