News Notes.

No less than 33,052 persons paid a quarter each to get into the World's Fair grounds at Chicago last week.

Prof. Koch gives it as his opinion that cholera cannot be transmitted through the post by means of letters or printed matter.

O'Connor and Hanlan were matched Monday to row Gaudaur and Hosmer on October 15th for the double scull championship and \$1,000 a side.

The Toronto Lacrosse Club has lost every championship match this season. On Saturday they were defeated by the Montrealers by 4 games to 3.

The one hundredth anniversary of the opening of the first Parliament of Upper Canada was fittingly celebrated in Queen's park, Toronto, on Saturday. A number of prominent members of the Local Legislature spoke.

At the annual match between Canadian cricketers and United States, played at Philadelphia last week, the Canucks were defeated by an innings and 222 runs. This is the worst defeat on record between the two countries.

A special meeting of the Provincial Board of Health was held in Toronto on Saturday, when the regulations for guarding against cholera were prepared and submitted to and approved by the Lieutenant Governor in Council.

Two visitors to the Toronto Exhibition—Frank Harper and Robert Hamilton—were found dead in their beds in a lodging house, on York street. They apparently were unfamiliar with the use of gas, and were asphyxiated in their beds.

It is semi-officially stated that Sir John Abbott will continue to be Premier, perhaps until Christmas, and that at the wish of his colleagues he will visit England as the Premier of the Dominion, instead as the retired head of the Administration.

Mr. J. D. Edgar has refused to go before the Royal Commission appointed to investigate charges about Sir A. P. Caron, formerly Minister of Militia. The reason of the refusal is that the charges are not those made by Mr. Edgar, but garbled to suit the accused.
