Good Roads for York County Council Decides Upon System.

Will Submit a By-law to the Ratepayers—The Roads Which Council Proposes to Take Over.

The York County Council have decided upon a schedule of county roads. It is proposed to spend \$150,000 improving them, including a portion of the Ontario Government's million-dollar good roads grant. The Council on Friday drafted a by-law, which will be submitted to the ratepayers of the county. Following is the County roads schedule as arranged:—

- (1) Yonge street from the northern limit of the city of Toronto to the junction therewith of the Bradford road in the village of Holland Landing, except those portions in North Toronto, Richmond Hill, Holland Landing and the town of Aurora.
- (2) Kingston road, from the eastern limit of the city of Toronto to the Highland Creek bridge.
- (3) The Kennedy road, beginning on the Kingston road between lots 28 and 29, in the township of Scarborough, and Markham town line; thence north along the sixth concession line of Markham to the Markham and Whitchurch town line.
- (4) Lake shore road in Etobicoke township, from 300 feet west of the Humber bridge to the eastern approach of the Etobicoke river bridge.
- (5) Dundas street, from the westerly boundary of Toronto Junction to the boundary line between York and Peel and the Malton road, in the township of Etobicoke.
- (6) Vaughan plank road, from the city limits to the York and Vaughan town line, thence northerly along the third concession line of Vaughan to the northern limit of lot No. 15, thence westerly along the said northern line to the fourth concession line, thence westerly along the said fourth concession line to the northern limit of lot 20, in said township.
- (7) Weston and Vaughan road, from the northern boundary of Toronto Junction through the township of York, Village of Weston, townships of Etobicoke and Vaughan, village of Woodbridge, thence northwesterly to the village of Kleinburg, thence northerly along the ninth concession line of Vaughan and King to and through the Village of Schomberg, to the north town line of King, except such portions of the road as lie between Weston and Woodbridge.
- (8) Commencing at Yonge street on the road between lots 35 and 33, thence easterly through the 1st, 2nd, 3rd, 4th, 5th, 6th and 7th concessions, to the village of Markham.
- (9) Commencing at the eastern boundary of Aurora on the road between lots 80 and 81, thence easterly to the village of Ballantrae, thence south on the 8th concession line to the south town line, thence along the said town line easterly to the 9th concession line; 14½ miles.
- (10) Kettleby road, commencing at Yonge street, in Aurora, between lots 80 and 81, along the side road to the 3rd concession line, thence north on the 3rd concession line to the road between lots 25 and 23, thence west to the 4th concession line, thence north along the Kettleby road, across the 4th and 5th concessions to the 6th concession road; 7½ miles.
- (11) Commencing at Yonge street between lots 65 and 66, thence westerly to the 6th concession line, thence south to King Station; 6½ miles.
- (12) Queen street road, commencing at the 3rd concession line of King, easterly along the town line between East Gwillimbury and King, across Yonge street to the 3rd concession line of Whitechurch, thence northerly along the 3rd concession line of East Gwillimbury to the road between lots 10 and 11, thence easterly to the village of Mount Albert; 13½ miles.

If four township councils in the county refuse to pass the by-law, the County Council will have to submit it to the ratepayers. If it is not opposed by that number of townships, the by-law becomes law by the County Council merely passing it. At any rate, nothing further will be done by the County Council in the matter until the November session.

Vaughan Council

Council met on Tuesday, July 14, at 1 o'clock p. m. Members all present. Minutes of last meeting read and confirmed.

A communication was received from John Ramsden, Esq., Clerk of York County, giving notice that a special meeting of York County Council would be held on the 15th and 16th of July to consider the advisability of taking over certain leading highways throughout the county, as a system of County roads under the Provincial Statute, to be known as "An Act for the improvement of Public Highways." The Reeve and Councillor D. M. Malloy were appointed delegates
