Vaughan Council

Council met on October 13. Reeve
in the chair. Members all present.
Minutes of last meeting read and
approved.

A communication was received from
A. McMurchy, Esq., solicitor for the
C. P. R., submitting to the council a
proposition for closing a given road
on the east half of lot 20, in the 9th
con., from the sideload between lots
20 and 21, south to the place where it
crosses the railway, and submitting
another road to be purchased by the
company from the west half of lot 20,
on the west side of the railway track.

The proposal is looked upon favor-
ably by the council, but no action was
taken in the matter. The clerk was
instructed to ask for a representative
of the company to appear at the next
meeting of the council.

A petition was presented by a large
number of ratepayers residing on the
5th con., complaining that the road
from lots 20 to 25 is not the proper
width, and asked the council to take
legal steps to have the persons own-
ing said lots to remove their fence to
the proper line.

Rev. W. N. Chantler was present in
behalf of the Maple Public Library
Board, and requested the council to
grant the usual donation to aid in
maintaining the Reading Room in
connection with the Public Library.

Thomas—Longhouse—that the clerk
employ P. S. Gibson, C. E., to locate
the proper line on the 5th con., from
lots 20 to 25 inclusive; also the Gravel
Road through Kleinburg village, and
the 12th con., known as the Indian
line.

Longhouse—Devins—that the treas-
urer pay to the treasurer of the Maple Pub-
lic Library the sum of \$20.

the chair.

Communications were read from A.

deem it advisable to sell toll house on
Yonge street and that Mr. Francis be

that same be sold to best advantage.

Hoover—Francis—that Mr. Morrison
be appointed a com. to repair bridge
opposite lot 8, con. 9 and culvert be-

tween 9 and 10th con., south townline;
also culvert on con. 11, opposite lot 3.

Harper—Morrison—that the Reeve
be commissioned to repair bridge be-
tween lots 10 and 11, con. 3, also bridge
opposite lot 10, con. 4.

Harper—Morrison—that D. Harring-
ton be paid \$173.09 for lumber fur-
nished the municipality to date.

A large number of accounts were
ordered to be paid.

Francis—Hoover—that this council
is of the opinion that the railways and
other great corporations are not bear-
ing their fair share of taxation in this
province, and that consequently the
people whom we represent are com-
pelled to bear an unjust share of the
burden of taxation. Therefore we de-
sire to go on record in favour of the
Pettypiece bill.

Francis—Hoover—that the reeve be
appointed a delegate to act with dele-
gates from other municipalities in re-
ference to Pettypiece bill.

Harper—Francis—that Mr. Morrison
be a com. to cut down trees at railway
crossing, con. 9.

Council adjourned to Nov. 10.
