

Provincial Election.

To the Electors of East York:

I am, as you know, the Liberal Candidate in the coming election to select a representative for the East Riding of the County of York. I am desirous of obtaining the vote of every elector of the riding who can conscientiously approve of my candidature and in order that the Electors of East York may know my views on some of the subjects which will require legislative attention in the near future, I desire to state where I stand in respect to such of them as appear to me as being the more pressing.

I believe that it is of the utmost necessity that our elections should be untrammelled by improper influences and be a free and honest expression of the opinion of the electorate, and that electoral corruption is a serious menace to the welfare of the State.

I believe in the initiative and in the referendum.

I believe in the public ownership, operation and control of public utilities.

I believe in the necessity for reformation in the manner of the appointments to, and advancement within, the civil service, or as it is called, "civil service reform"; I believe that such appointments and promotions should be in the hands of an independent commission; that what is now looked upon as party patronage belongs to the country and not to either party, and I believe that the best man who will accept the position should be appointed to the position irrespective of his party affiliations.

I believe in the immediate necessity for a very considerable measure of law reform and a simplification of legal practice and procedure.

I believe in the immediate necessity for a full, complete, considerate and merciful administration of the criminal law, and in a greater regard for the rights of those charged, and in a lesser regard for the personal convenience of those, from time to time, acting as administrators; that it is immediately incumbent upon our Local Legislature to carefully consider and legislate towards a more Christian and humane treatment of those whom we assume to call criminals; to prevent by removal from evil association and surroundings, those young in years, giving them an opportunity to become good citizens instead of leaving it, as it is now almost impossible for them to be other than what we call criminals.

I believe that the representative of the constituency should be elected to represent such constituency free from party pledges or party obligations, subscribing to well defined principles of policy only; and I believe that it is the duty of the representative of any constituency to approve of all good measures and to disapprove of all bad or doubtful measures from whatever source emanating; to act in all cases as an independent and courageous representative.

I believe that majorities should rule and govern.

I believe in the preservation, development and careful administration of the public revenue and of the public domain, and the administration of public patronage, in the interests of the people, and not in the interests of either party or the favorites of either party.

I believe that corporation influence is much too potent in the halls of our Parliaments and Legislatures, and that the rights of the people are too often neglected.

I believe that it is immediately incumbent upon our Legislature to carefully consider and legislate towards the further advancement of agriculture and mining within the Province, and to the betterment of the conditions surrounding the lives of the great wage-earning class.

I believe that the income of wage-earners should not be taxed.

I believe in the "Good Roads Movement."

I believe that a well considered plan of reforestation is urgently necessary.

I believe that the settler should have all timber and minerals on his lands.

I believe that it is incumbent upon our Local Legislature to make further provision for the care of the insane and otherwise helpless and of the aged.

In case you see your way clear to support me in my candidature for election as such representative, I pledge myself, in case I am elected, to consider myself a representative of all the electors of the Riding and not of any part or class; of the man who worked hardest against me to the same degree as the man who worked for me. And I further pledge myself to act in all things as my best judgment directs, without fear, favor, or affection.

In coming to a conclusion, I ask you to consider the manner in which I performed my duties while representing the Crown as Crown Attorney for the City of Toronto.

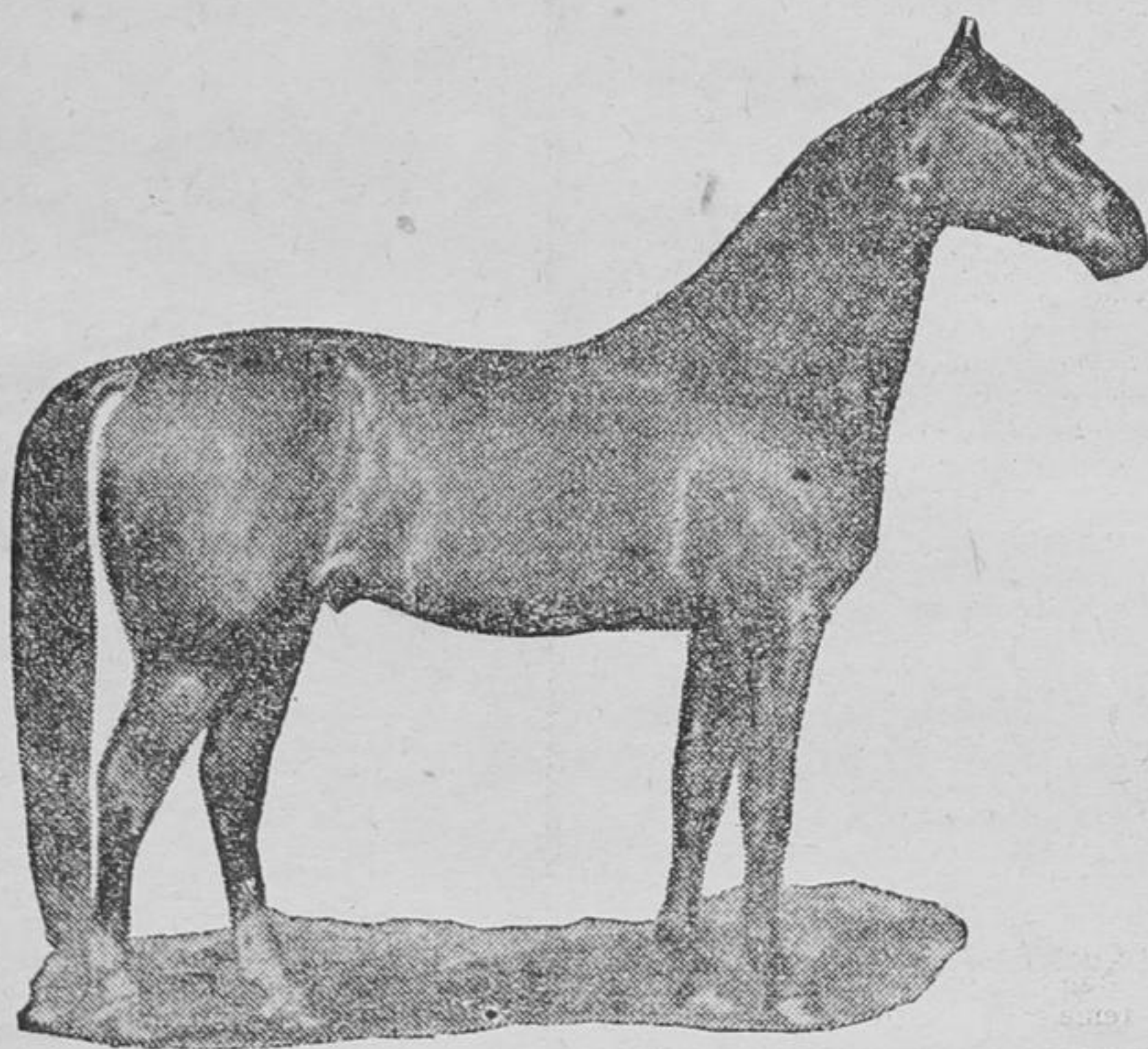

GORMLEY GLEANINGS.

The General Conference of the Brethren (Tanker) Church will be held here next week. The sessions will commence on Wednesday morning and close on Friday afternoon. There will be preaching services each evening at 7.30, to which all are cordially invited. The Conference sessions are open, in a limited sense, namely, to those interested in religious work. The delegates, who come from as far east as Pennsylvania and west as California, will arrive on Tuesday over the C. N. O. R. some hundreds strong. Of course, all who come are not delegates (there are no lady delegates) many coming as visitors. The C. N. O. is a great improvement on former facilities. This is the third Conference held here. The last was ten years ago when the Metropolitan was an infant. Early cars had been promised for the return trip to make connections by boat and train. Hour after hour was spent by the waiting crowd singing in front of the old shack known as "Waiting Room." Finally at a late hour two little cars hove in sight. Connections were all missed, meaning many dollars and much inconvenience to our American visitors. The other, nine years before that, came by "Proctor's Busses" from Maple station.

The council gave the deputation an assurance that they would give the matter serious consideration.

By-law No. 216 to borrow \$600 needed for current expenditure was introduced by Councillor Trench. The by-law received its several readings and was finally passed.

Synopsis of Canadian North-West

HOMESTEAD REGULATIONS

ANY even numbered sections of Dominion Lands in Manitoba, Saskatchewan and Alberta, excepting 8 and 23, not reserved, may be homesteaded by any person who is the sole head of a family, or any male over 18 years of age, to the extent of one-quarter section of 160 acres, more or less.

Application for entry must be made in person by the applicant at a Dominion Lands Agency or Sub-Agency for the district in which the land is situated. Entry by proxy may, however, be made at an agency on certain conditions by the father, mother, son, daughter, brother or sister of an intending homesteader.

The homesteader is required to perform the homestead duties under one of the following plans:

(1) At least six months' residence upon and cultivation of the land in each year for three years.

(2) A homesteader may if he so desires, perform the required residence duties by living on farming land owned solely by him not less than eighty (80) acres in extent, in the vicinity of his homestead. Joint ownerships in land will not meet this requirement.

(3) If the father (or mother, if the father is deceased) of a homesteader has permanent residence on farming land owned solely by him, not less than eighty (80) acres in extent, in the vicinity of the homestead, or upon a homestead entered for him in the vicinity, such homesteader may perform his own residence duties by living with the father (or mother).

(4) The term "vicinity" in the two preceding paragraphs is defined as meaning not more than nine miles in a direct line, exclusive of the width of road allowances crossed in the measurement.

(5) A homesteader intending to perform his residence duties in accordance with the above while living with parents or on farming land owned by himself must notify the Agent for the district of such intention.

Six months' notice in writing must be given to the Commissioner of Dominion Lands at Ottawa, of intention to apply for patent.
