DEATH OF JAMES PAULIN.

Relative to the death and burial of the late James Paulin we copy the following from the Enterprise-News of Arthur, Ont .: - We this week chronicle the death of one well known to almost all our readers, one who was held in high esteem and generally respected, passed away at his late residence on Frederick St., on Saturday morning, in the person of Mr. James Paulin. Though generally a robust man, for the past year and a half he had been in declining health. Four weeks ago he was taken ill at the Sunday morning service, and was removed to his home where he slowly sank until death occurred.

The deceased was a native of Berwickshire, Scotland, where he was born in 1845. In 1856, he with his parents, the late Mr. and Mrs. Jas. Paulin, immigrated to Canada and settled in Ontario, near Woodstock. For nine years he was in the service of a Mr. Lindsay, a store keeper who also kept the Innerkip post office. During that time one of his duties was to draw the mail twice a week from Woodstock.

After leaving Innerkip he came to Arthur Township, where his parents had settled some years before. He later purchased from Mr. W. Buchanan, the farm on the O.S.R., now owned by Mr. James Kelly, where he resided for many years. Shortly after he was married to Miss Caroline Ryan, by whom he is survived.

In 1899 he moved to Richmond Hill where he purchased a fifty acre farm. While there he took an active interest in Municipal affairs, and was for two years a member of the town council. In November, 1907, he returned to Solicitors. Arthur, where he has since resided. In politics he was a life-long Liberal, in religion a consistent member of the Presbyterian denomination, being for many years an elder of St. Andrew's Church, Arthur.

The funeral took place on Monday, May 24th, at 2.30 p.m., to Greenfield Cemetery, service at the house and grave being conducted by Rev. Mr. Richardson, B.A. The pall bearers were Messrs. Wm. Peterkin, William Scott, John Sweeny, J. Mitchell, Geo. Hunter and W. Maitland.

Messrs. A. J. Anderson and W. A. Baird were on Saturday elected aldermen in the new ward in Toronto-formerly Toronto Junction. Mr. Anderson's vote was 777, Mr. Baird's 604.

FATAL ACCIDENT.

Mr. James Duncan. 70 years of age, a prosperous farmer at Emery, while hurrying to catch a train, crossed in front of the engine as it rushed into Weston station on Tuesday, and was instantly killed. Deceased leaves a widow and six sons and daughters. He was a director of the York Fire Insurance Company, and also of the York Farmers' Colonization Company. He was a cousin of Mr. John Duncan of this place.
