Only a short time ago His Majesty, King Edward, sent a personal telegram to Sir Wilfrid Laurier, bearing testimony to his loyalty to the Crown and empire. In the face of this does it not sound farcical to occasionally hear political opponents trying to make people believe that Canada's Premier is disloyal, and that his navy policy means separation from Britain. Such efforts only show to what lengths some men will go in order to injure the good name of those who to them are politically opposed.

Intelligent readers must be weary of reading day after day speeches in Parliament on the Navy Bill. Nothing new is attempted, but hours of valuable time are consumed in the reading of quotations that have been given time and again. All things considered it is little wonder that the amendment moved by Mr. Borden, leader of the Opposition, was voted down by a Government majority of 55. It is difficult for Conservative speakers to explain satisfactorily why they announced a certain policy and expressed certain opinions last year, and now ask the country to accept another policy diametrically opposed to the first one. Mr. Borden and Mr. Foster and other leaders were last year in favor of a Canadian navy, now they are endeavoring to lead the rank and file of their party in rebellion against it. But it is of no use. Sir Wilfrid Laurier has the true Canadian idea, and the steps taken are those suggested by the British Admiralty as being the best under the circumstances.

If we are to judge by the reports given in the daily newspapers we must come to the conclusion that the gentlemen of the race track who are pleading for gambling in connection with horse-racing, are placing themselves in an unenviable position before the public. We do not find that those gentlemen claim that gambling is good for young men or old men, from a moral standpoint, but they argue that in order to encourage the breeding of fast horses racing must be allowed, and that racing cannot be made to pay if the betting and gambling be eliminated. Therefore they say the proper thing for Parliament to do is to make gambling and betting on race tracks legal. This is tantamount to saying that if a man cannot conduct his business successfully because of his drinking habits, the proper thing for him to do is to give up his business. Miles of evidence are at hand to prove that betting and gambling at race meets operate to the detriment of young manhood in this country. Therefore the question of horse breeding should be treated by Parliament as a secondary consideration. No person need raise objection to an honest horse-race properly conducted. The truth of the matter is that many men who claim to be enthusiastic over a race, only look upon the contest as a means of making money.
