




Whereas the Kichmond Hill Ratepayer's Association has requested the Municipal Council of the Village of Richmond Hill to purchase the "Crosby property" for Municipal purposes, and to provide funds for the said purchase and also for the cost of necessary alterations and repairs to the said property, and

best interests of the said Village that the said request be granted, and

Whereas it will require the sum of Two thousand and Eight hundred dollars for the purchase of the said property, and

Whereas the General Debenture debt of the said Village is \$45,649.51 of which no part of the principal or interest is in arrear, and whereas in order to provide for the said debt it is expedient to issue debentures of the said Village to the amount of Four thousand and three hundred dollars, bearing interest at the rate of 51 per cent per annum, and that such principal sum shall be repayable in yearly sums extending over a period of twenty years from the date of issue of such debentures of such amounts that the aggregate amount payable for principal and interest in any year in respect of the principal shall be equal as nearly as may be to what is payable for principal and interest during each

Now, therefore the Municipal Council of the Village of Richmond Hill emets as follows,-

1st. That the "Crosby property" situated on the East side of Yonge street in the said Village, consisting of the West half of Village Lot number Thirty nine, Plan 481, together with the buildings thereon, be purchased by this Council for the sum of Two thousand and eight hundred for Municipal purposes.

2nd. That necessary alterations and repairs be made to the said property at a cost of not more than Fifteen bundred dollars.

3id. That the Reeve of the Curporation of the Village of Richmond Hill be, and he is hereby authorized to borrow the sum of Four thousand and three hundred dollars on the credit of the said Corporation for the purposes aforesaid and to issue Debentures of the said Corporation for the sum of Four thousand and three hundred dollars payable at the office of the Treasurer of the said village.
