EASY TO RESOLVE

At the recent session of the County Council a resolution was moved and carried, "That the constabulary and magistrates of this county be and are hereby requested and required to take stern and stringent action in the matter of any appearance of the principles of Bolshevism within this county, by imposing such penalty as will tend to the complete suppression of the menace."

After the motion was read one of the members asked the Warden for a definition of "Bolshevism," but, according to a report in the city papers, he said it had to be taken as read, and his answer was followed by a burst of laughter.

Surely, that was not a subject for laughter. If the County Council think Bolshevism a menace, it should be taken seriously. It takes little courage to pass resolutions. To follow them up and act upon them is another matter. And the constables and magistrates are surely entitled to know what is expected of them.

At a session of the Ontario Women's Institutes held last week in Toronto Hon. Dr. Cody, Minister of Education, announced that he had authority from Premier Hearst to say that a bill is in preparation which is described as "An Act to render farmers' wives and daughters eligible as members of school boards." At present they can act in such capacity only if they are on the assessment roll in their own right. The new measure is to give eligibility to the wife or daughter of any farmer who is on the assessment roll, provided she resides on the farm.

We believe the Government will find a difficult task in showing the justice of such a measure. Why should farmers' wives and daughters be given a privilege that is denied the wives and daughters of mechanics, tradesmen, shopkeepers or other classes? Many women would make excellent trustees, whether they reside on a farm or in a hamlet. Surely intelligence should count for more than occupation.

We believe the fact of the matter is, the Government does not stand at the present time too highly in the estimation of the farming community, and they wish to carry favor by a little piece of flattery. But the farmers' wives and daughters will not ask for more than equal rights and fair play.

In the January number of "Better Business," a journal published in Winnipeg, Mr. C. H. Ellston Debenham's Ltd., Toronto, has an excellent three column article, under the heading "Co-operation the Keynote of Success." The article shows conclusively that Canada is full of business, and that all that is necessary to build up our great country is for capital and labor to go hand in hand and work together for the good of the country and mankind. As long as capital and labor are at variance, just so long will the progress and prosperity of Canada be retarded.
