Given the reception of several comments requesting an extension to the comment period, the Department has decided to extend this comment period in order to provide everyone who wishes to participate in the consultation process with the opportunity to do so. ***The period during which comments may be submitted for this initiative is now from June 1, 2019 to September 30, 2019.***
