"Sludge Diet" debuts in the County

Sunday afternoons March 2 and 9, a coalition of farmers and other citizens will present the first public showings of Sludge Diet, a highly acclaimed documentary on the dangers of spreading sewage sludge on rural lands. Released in 2006, Sludge Diet has been nominated Notable Video of the Year by the American Library Association.

Shot on location in Canada, the US, France, and Switzerland, the film explores the devastating impacts that the increasingly toxic stew of sludge can have on soil, water and human health. Strong farmer resistance has led to a national ban in Switzerland, and may soon accomplish the same in France. Sludge Diet features scientists, government officials, victims of sludge poisoning, as well as farmers and other citizens organizing to stop the land-spreading of sewage and industrial sludge.
