

37TH COUNCIL NEWS (Cont'd):

Motion that this Council approve payment of the Finance Accounts, as presented was carried.

Motion that this Council grant permission for a copy of Resolution No. 26 of December 4, 1969, as follows, to be forwarded to Mr. John Purcell of Wyatt and Purcell, Lawyers, 103 Darling Street, Brantford, Ontario:

"That this Council approve the recommendation of the Welfare Committee that no consideration be given to the Children's Aid Society in their claim against the Estate of Grant Wright."  
was carried.

Motion that this Council forward an invitation to Mr. Nigel H. Richardson, Director of Municipal Affairs, 801 Bay Street, Toronto 5, Ontario, to come to the next meeting of Council on Thursday, April 2, 1970, to discuss the planning studies he is conducting in Haldimand and Norfolk Counties was carried.

Motion that this Council extend an invitation to Mr. William Knowles, M.P., Haldimand-Norfolk, and Mr. James Brown, M.P., Brant, to attend the next meeting of Council on Thursday, April 2, 1970, at 2:00 p.m. was carried.

Motion that this Council request the Six Nations Recreation Commission to canvass the Six Nations Indian Reserve to see how many trophies will be released for public display purposes; and when canvassing is complete, the Council will then look into the matter of securing a place to display these trophies, if it is warranted, was carried.

Motion that this Council approve seven applications for Hydro service was carried.

Motion that this Council approve the appointment of Cyril Fraser, #68 Walker Mohawk, as District No. 4's representative to the School Committee was carried.

Motion that this Council make requisition for a grant for Administration of the Capital Grants Housing Program for the Fiscal Year 1970/71 in the amount of Five Thousand Dollars (\$5,000.00) was carried.

Motion that this Council make requisition for 100% of \$125,000.00 for the Capital Grants Housing Assistance Program for the Fiscal Year 1970/71, to be drawn quarterly was carried.

Motion that in relation to the surrendered lands, not sold, in North Cayuga Township, that letters of Patent be issued at Four Hundred Dollars (\$400.00) per acre, less the towpath of 1 chain in width be excluded from the patent, was carried.

Motion that this Council request a representative from Indian Affairs Branch to meet with the Six Nations (temporary) Water Committee to set up a By-Law, was carried.

Motion that this Council approve in principle only the draft permit covering the agreement for the gas and oil rights on the Six Nations Indian Reserve, as amended, and forward to Indian Minerals Section, Indian-Eskimo Economic Development Branch, Department of Indian Affairs and Northern Development, Ottawa, Ontario, for final agreement which is to be returned to the Six Nations Council for final approval was carried.

Motion that this Council transfer from the following to "Audit and Miscellaneous" in our 1969/70 Band Budget the sum of \$759.05 was carried.

It was duly moved and seconded that this meeting be adjourned until 10:00 a.m., Thursday, April 2nd, 1970.
