

Minutes of the Fourth General Meeting of the Thirty-Seventh Elected Council - April 2/70

The fourth General Meeting of the Thirty-Seventh Elected Council of the Six Nations Indian Reserve was opened with a prayer by Rev. K. Welch of the Ministerial Association in the Council Chamber, Ohsweken, Ontario, on the above noted date, with Chief Richard Isaac, presiding.

Motion that this Council request the Six Nations Public Library Board to grant space in the Six Nations Public Library building to the Six Nations Recreation Commission for the purpose of displaying the trophies that are being collected for display purposes on the Six Nations Reserve. Carried.

Motion that this Council approve the recommendation of the Health Committee, to approve the establishment of service clinics, of a consulting capacity only, on the Six Nations Indian Reserve, by the Faculty of Medicine of the McMaster University, Hamilton, Ontario. Carried.

Motion that this Council approve the recommendation of the Health Committee to approve of two (2) student Nurses, at one time, from the Hamilton Civic Hospital, to attend the above mentioned service clinics during the period of April 29 to July 9, 1970. Carried.

Motion that this Council approve the recommendation of the Welfare Committee to approve the expenditure made for Welfare purposes during the month of March, 1970, in the amount of \$5,545.97. Carried.

Motion that this Council delegate Councillor Clifford Lickers and Councillor Gordon Hill to go and speak to the Grade 13 pupils at Welland Eastdale Secondary School, Welland, Ontario, at 10:00 A.M. on Monday, April 13, 1970. Carried.

Motion that this Council forward an invitation to the Grade 13 History Class at Milton District High School, 396 Williams Avenue, Milton, Ontario, to attend the next meeting of Council, which will be held on Thursday, May 7, 1970, and that the students be prepared for a 30 minute question and answer period. Carried.

Motion that this Council approve the appointment of Claudine VanEvery and James Styres to the Six Nations Recreation Commission for a period of three (3) years. Carried.

Motion that this Council grant to the Six Nations Recreation Commission the right to rebuild the tennis courts at the former R.C.M.P. Barracks, if it is suitable for the purpose, after investigation. Carried.

Motion that this Council refer the request of the Six Nations Recreation Commission to the Public Lands Committee in relation to the use of Chiefswood Park "Free of Charge" to run a summer day camp for the children of the Six Nations Indian Reserve for a period of six weeks. Carried.

Motion that this Council refer to the Public Lands Committee the matter of a By-law respecting the control of unsightly, dismantled, inoperable, wrecked cars on the Six Nations Indian Reserve. Carried.

Motion that this Council call tenders up until 5:00 p.m., Wednesday, May 6, 1970, for the supply and delivery of:

800 only 24 oz. loaves of freshly baked, unsliced, unwrapped bread.

800 # of first grade, mild 90 day Cheddar Cheese, cut in triplets.

To be delivered on Monday, May 18, 1970, to the Community Hall, Ohsweken, Ontario, at 9:00 A.M. Carried.
