Motion that the planning of the Proposed Sewer System, Village of Ohsweken, Six Nations Indian Reserve, be assigned to the Planning and Development Committee of the Six Nations Council to work in conjunction with the Village Planning Committee. Carried.

Motion that this Council approve the recommendation of the Roads Committee to submit to the Minister of Highways for his approval the Normal By-Law for the sum of ONE HUNDRED AND THIRTY ONE THOUSAND DOLLARS (\$131,000.00), made under the Highway Improvement Act covering the estimated expenditures on the Construction and Maintenance of Roads for the Calendar Year 1970.

Motion that this Council approve the recommendation of the Roads Committee to submit to the Minister of Highways for his approval the Supplementary By-Law for the sum of ONE HUNDRED AND NINETY TWO THOUSAND SEVEN HUNDRED DOLLARS (\$192,700.00), made under the Highway Improvement Act covering the estimated expenditure on the Construction and Maintenance of Roads for the Calendar Year 1970.

Motion that in consideration of receipt of the Indian Affairs funds appropriated, in the amount of SEVENTY ONE THOUSAND DOLLARS (\$71,000.00), for the operation and maintenance of roads within the Six Nations Indian Reserve, this Council will accept full responsibility for the administration of the program for which funds are provided and will, to the greatest extent possible, insure that standards of program performance will not be less than those for Branch administered programs. It is understood that the grant funds applied for will, when provided, be deposited in our Band Fund Revenue Account and administer d in accordance with the provisions of Section 68 of the Indian Act. Carried.

Motion that this Council turn over to the Royal Canadian Mounted Police Detachment at Simcoe, Ontario, the evidence that was found in garbage dumped along Road No. 231, Tuscarora Township, Six Nations Indian Reserve, and request that charges be pressed under the Six Nations Indians of the Grand River By-Law 7A Respecting Disposal of Garbage.

Carried.

Motion that this Council authorize the repair of the 550-6 Adams 1959 Road Grader by Wabco Equipment Canada Limited, Paris, Ontario, and that the Road Foreman, Kenneth R. General, be authorized to dismantle the Clutch Assembly and Power Take-off Shaft ready for servicing.

Motion that this Council forward an invitation to the Sargeants of the Ontario Provincial Police Detachment in Brantford, and the Royal Canadian Mounted Police Detachment in Simcoe, to come to the next meeting of Guncil to be held on Thursday, May 7, 1970, commencing at 10:00 A.M., to discuss the patrolling of the Six Nations Indian Reserve.

Carried.

Motion that this Council authorize payment of the Finance Accounts, as presented. Carried.

Motion that this Council approve the recommendation of the Lands Committee to approve 10 transfers of land and 1 sale agreement. Carried.

Motion that this Council approve the Draft Constitution\*of the Association of Iroquois and Allied Indians, and forward same to the Association secretary, Mr. Frank Benedict, P.O. Box 352, Cornwall, Ontario, for presentation at the next meeting of the Association. \* - The draft of this constitution will follow the minutes of Council.

Motion that this Council advertise for the rental at \$40,00 per month, utilities extra, of the Band Owned house, formerly occupied by Leo Winnie, in the North Half of Lot 6, Concession 6, Township of Tuscarora.
