MOVED, that this Council request the Department of Indian Affairs to give their opinion, in writing, as to whether or not Indian Affairs Branch will bear the 20% cost over and above the 80% borne by the Province under the General Welfare Assistance Act, for an enfranchised Indian. CARRIED.

MOVED, that this Council approve the five, (5), hydro applications. CARRIED.

MOVED, that this Council Form a delegation, including Mr. B. H. Kellock of Waterous, Holden, Kellock & Kent, Barristers and Solicitors, Brantford, Ontario, and Mr. Wm. KcKim, Regional Director, Ontario, to meet with the Hon. A.A. Wishart, Q.C., Minister of Justice and Attorney General, in the Parliament Buildings, Queen's Park, Toronto, Ontario, at 10:00 A.M., Friday, October 23, 1970. CARRIED.

MOVED, that Chief Richard Isaac, Mrs. Rena Hill, Gordon Hill, Ronald Monture, William White, form a delegation to meet with the Hon. A.A. Wishart on Friday, October 23, 1970. CARRIED.
