- ... That this Council adopt the minutes of the meetings of October 2, 1969, and October 14, 1969, as read.

- ... That this Council authorize Clifford Lickers, Chairman of Housing 494, to take care of the necessary repair work to be done on the Band owned house situated in the South Half of Lot 1, Concession 6, Township of Oneida. Carried.
- ... That this Council grant the request of the Salvation Army to set aside an area of 1.6 acres of their present holdings for use as burial ground and to acquire an additional three acres of land adjacent to their present property for use as a cemetery.

 Carried.
 - ... 5 transfers of land were approved and carried.
- ... That this Council agree in principle to an agreement with Mrs. Peggy Olmstead of Peggy-Claire Hats, Hamilton, Ontario, to use the upper story of the Nursing Home garage as a site for the manufacture of hats and other related items. The Council is to supply the building free of rent and will take care of renovations. The Chief is to take part in all meetings to prepare contract. Carried.
- ... That this Council approve expenditures made during the month of October 1969, for Welfare purposes, in the amount of \$4,091.76. Carried.
- ... That this Council agree to a Contour Survey of the Village of Ohsweken to be made by the Geodetic Branch of Energy Mines and Resources, Ottawa, with the co-operation of William L. Sears and Associates Limited, Consulting Engineers, of Stoney Creek, Ontario.

- ... That this Council hold a Special Council on Wednesday, November 12, 1969, commencing at 8:00 P.M., to deal with the Boychuk Report in relation to Gas Production and Distribution on the Six Nations Indian Reserve. Carried.
- ... That this Council gives its consent to Bell Canada for the removal of the coin operated telephones from the Lady Willingdon Nursing Home and Johnson's Store and that the coin operated telephone remain in the Ohsweken Community Hall. Carried.
- ... That this Council grant the request of Mrs. Jean Hill, No. 440 Lower Mo-hawk, of R.R. #6, Hagersville, Ontario, for permission for Sunday opening of her pool room, situated in the South Half of Lot 33, Concession 3, Township of Tuscarora. Carried.
 - ... 7 Applications for hydro were approved and carried.
- ... That this Council authorize the Lands Committee Chairman, Ranson Jamieson and Victor Porter to see Mrs. William (Canoe) Johnson in relation to her offer to sell 18 acres of her property to the Six Nations Council for the sum of Eight Hundred Dollars (\$800.00) and that they report their findings at the next meeting of the Lands Committee. Carried.
- ... That this Council defer for one month the matter of the amendment to the Six Nations Library Constitution.
