Six Nations Left Out in Act Changes

Six Nations Council Thursday drafted a formal letter of protest to the Indian Affairs minister over the lack of a Six Nations representative in the final draft of amendments to the Indian Act.

The final draft of the act will be made in Ottawa, probably within the next month. Representatives of various Indian groups to the final draft was selected at a recent week-long conference in Toronto which was held as preliminary discussions on what Indians thought the act should say.

No representative of the Six Nations was elected to attend the Ottawa meeting.

The letter to the minister will contain a plea for representation of the 10,000-member Six Nations group.

Firm Awarded Bridge Pact

Maple Engineering and Construction Limited of Rexdale received the contract to construct a new bridge on Road 266 on the Six Nations Reserve.

The Six Nations Council accepted the company's \$64,239 tender at a meeting in Ohsweken Thursday. Construction will begin soon.

Council received word that the department of highways had accepted the annual road budget which was set at \$131,000.

Of this figure, the province of Ontario will provide about \$86,000. The balance of the money will come from road allowances of \$25,000 of band funds and Indian affairs allowances of \$295,000.

Cayuga Annuity Payments 1969

Payment at the rate of \$5 per share will be made to members of the Upper and Lower Cayuga bands. The pay list will comprise those members of the band who are included in the Registered Indian Record (membership list) as of 31 December 1968. Persons not registered at that date will not be eligible for the 1969 payment.

Membership tickets must be presented and where persons are drawing shares for other members, a signed order must be presented.
