RESERVE GAS SYSTEM UPDATED

Natural gas consumers on the reserve, last year, complained that their gas pressure dropped to practically nil during the cold spells.

This winter Mr. Hyslop, owner of Hyslop Construction Natural Gas Division in Ohsweken, has assured that all 250 homes should have no pressure problems even when sub-zero temperatures put increased demands on the

system.

Mr. Hyslop, a non-Indian, purchased the natural gas Company in the fall of 1971 from Petrol Oil and Gas Company and shortly after raised the gas rates. The consumers complained that the raise was unfair since they were not getting proper service. They drew up a petition and took it into Council. The result was a heated meeting with gas consumers, Council and Mr. Hyslop who promised to update

the system.

He installed 4,100 feet of 3 inch pipe between fifth and sixth line and 3,800 feet of 2 inch pipe has been laid along fifth line. He estimated the cost of improvements in excess of \$15,000.
