Council decided to request the Six Nations Sports and Cultural Memorial Centre to acknowledge receipt of the letter, dated April 13, 1973, from the Six Nations Water-Sewer Committee requesting payment for water use at the Arena on February 26th and 27th, 1973.

Council decided to invite Mrs. Lois Wilson, Human Rights Officer, Ontario Human Rights Commission to meet with Council on Tuesday, June 5, 1973 at 8:30

Council decided to notify Mr. H.E. Longboat, Acting District Superintendent of Education, that Ms. Audrey Powless need not appear before the board on May 22, 1973, and that he may proceed to hire her without her returning for another interview.

Council decided to appoint Councillor Sydney Henhawk as their representative to the Selection Board to interview for the Principal at S.S. No. 1 and for teachers, to be held on May 22, 1973, and that Councillor Wm. White be appointed as an alter-
