Presently they are assisting businesses in operation on Six Nations Re scrve, Kettle Point Reserve, Christian Island Reserve, Moose Deer Point Reserve, JAIL SUPERINTENDENT MOVED Walpole Island Reserve and two off the reserve.

Their work has covered bookkeeping. marketing, pricing, etc. Each business will receive a confidential report upon

completion.

Pat O'Callaghan, one of the graduate students said, "It is only a summer program ending August 23rd, but we hope to operate the same program next summer".
