Noted Indian Graduate of Caledonia High School (continued)

After the war was over, a grateful U.S. Government bestowed a citation upon Dr. Anderson commending him for his services, his loyalty, his devotion to duty and for keeping the Secret. He was honoured at the University of Buffalo at a banquet.

With the war over, Arnold was now able to direct his attention to peaceful pursuits. He was assigned to Union Carbide Chemical Co. of Niagara Falls, N.Y. as Director of Research. He was named assistant manager in 1955 and manager in 1959. He later became Production Manager of the New Chemicals Factory group of Union Carbides with offices in New York City.

In this position Dr. Anderson was responsible for the market development of Union Carbide water soluble polymers. These polymers are widely used as thickeners, film formers, binders, dispersants and sizes. They are important ingredients in latex-based paints, cosmetics, adhesives, paper products and textile chemicals. They are widely used in building and related industries as water-retaining agents for concrete, plaster, wall-board etc.

While in Niagara Falls, N.Y. Arnold was active in the American Chemical Society, American Institute of Chemical Engineers, Industrial Management Club, Niagara Club, Instrument Society of America, Messiah Lutheran Church of Lewiston (where he was Superintendent of Sunday School) Boy Scouts of America Council and Community Chest.

Dr. Anderson's compatriots on the Six Nations Reserve take great pride in his achievements and Caledonia High School is proud to have had a share in shaping his career.

Dr. Arnold C. Anderson is now World Co-ordinator of Union Carbides, and resides in suburban New York with his wife and two sons, when he isn't flying to other parts of the world.

Remainder of the agenda of the Six Nations Council meeting, March 6, 1969

It was moved and seconded that the rental of the apartments in the former R.C.M.P. Barracks be deferred for one month and that the resolution numbered as 25 February 6th 1969 be rescinded. Carried.

It was moved and seconded that since Mr. Torry Davis, caretaker of the Fair Grounds, cannot operate the seed cleaning plant because of asthma that his salary of \$2,700 per annum be reduced to \$2,400 per annum as of March 6, 1969 as agreed between Mr. Davis and this council after this council's discussion with him on this matter at this meeting, and that the operation of the seed cleaning plant be delegated to the Fair Grounds Committee. Carried.

That this council accept the report of the Lady Willingdon Nursing Home, Ohsweken, Ontario, dated March 5, 1969 as presented by Mrs. Ronald (Belva) Monture as follows:

Fuel and hydro bills will be paid by the Department of National Health and Welfare until the official opening March 31, 1969. M. Moses, R.N. Administrator. Carried.

It was moved and seconded that in respect to the request by the Indian Affairs Branch by letter dated February 22, 1969, which states in part as follows:

"If the Band Council in fact wishes to have administrative responsibilities and

"If the Band Council in fact wishes to have administrative responsibilities and financial resources for a sanitation program turned over to the council, a formal resolution will be required in accordance with procedures set out in Green Circular No. 797 dated January 29, 1968." that this Council leave the Sanitation Incentive Program as it is. Carried.

It was moved and seconded that members of the Board of Health be the Official Board of Management for the Lady Willingdon Nursing Home. Carried.

That this Council comply to the request of the Fair Grounds Committee to replace the wooden steps at the Community Hall with concrete steps and to replace one door with funds from the Revenue Band Budget under the item Improvement to Band Property. Carried.

That this Council accept the verbal report of the Housing Authority Chairman, James Clifford Lickers, of the houses inspected that were built with funds from the Capital Grant Housing Program. Carried.
