WORK TO BE COMMENCED ON T. & N.O. EXTENSION

Government Announces There Will Be Start Made on Right-of-Way 70 miles North of Cochrane This Winter.

Last week the Farmers' Government made official announcement that work would be commenced this winter upon the 70-mile right-of-way northwards from Cochrane on the T. & N. O. The estimated cost of this railway extension is \$3,500,000.00. It is understood the right-of-way will be run this winter from Cochrane as far north as a point known as Tin Can Portage on the Abitibi River. Later it is proposed to push the extension "on to the bay," and then the T. & N. O. will have direct connection with James and Hudson Bay.

The proposed extension, according to officials who favour the project, will pass through virgin territory containing great resources and with remarkable water power possibilities. According to these officials the country to be tapped by the extension has great agricultural, lumbering and mineral possibilities. The decision to start work on the extension follows a conference some days ago at North Bay between Premier Drury and the T. & N. O. Commission. The Premier is credited with saying that while the extension has long been urgently pressed by the people of the North Land, the Government in making the present commencement on the work is influenced also by the desire to relieve the unemployment situation in Ontario.

The new extension, it is claimed, will open up a great timber country. Also there will be immense sources of water power made available. At Tin Can Portage, the present proposed terminus of the extension, it will be possible, it is said to develop over 300,000 horse power. One possible source of development there has a possibility of about 200,000 h.p. There is a fall of about 200 feet in the Tin Can Portage district. By the way the Tin Can name is not a very euphonious one. It should be changed. The Advance would respectfully suggest that "Drury" be substituted.

The proposed extension will run north from Cochrane, crossing to the east side of the Abitibi River at the Long Sault Rapids, and will then follow the general northwesterly coast of the Abitibi, recrossing the river some little distance from the point where the Abitibi is joined by the Frederick-house River. From there the line will follow the western shore of the Abitibi to Tin Can Portage, which is about 70 miles north of Cochrane and somewhere around 80 miles from tidewater on James Bay. The ultimate intention is said to be to push the line on to James Bay and establish a great Canadian seaport there for this Province. Well, that's that!

Naturally the North Land is not displeased at the start to be made on the proposed extension. Most people here have felt that such an extension must ultimately be built to ensure the right development of the North Land. But there is in the minds of many a feeling that the work is undertaken at the wrong moment, and that, as usual in dealing with the North Land, the Government has bungled through its lack of knowledge. As the first and most pressing necessity for the development and progress of the North Land the need is for highways in the part now under settlement. To use a common expression, what is the use of trying to open up more territory when what is already partly settled is so poorly cared for. As a means of relieving the unemployment in Ontario the cutting of a right-of-way for a highway would be of much greater service. The cutting of a right-of-way for the proposed North Land highway to connect the various parts of the North with each other and with the road system of Old Ontario would give employment this winter to a much larger number than will be possibly used in railway construction. For the amount of money used the highway plan would give considerably more employment as well as being of much more direct and immediate benefit to the North Land. Of course, what the North Land really should have is BOTH works, but if only one were to be undertaken that one should be the Highway.

HARD TIMES AGAIN DOWN IN LISKEARD THESE DAYS

They don't have any fun at all down in the Farmers' Town of New Liskeard. Recently skunks have been troubling the farmers there, killing carrying away the choice young poultry but leaving the old hens strictly alone. One skunk was shot by one of the farmers in town last week, and the people of New Liskeard agree that they have not suffered as much since last winter when Timmins trimmed their famous hockey team.
