A New Liskeard citizen tells about hearing Premier Drury in the north and in the south in two separate and different speeches,—very separate and very different. At New Liskeard he heard the Farmer Chief refer to the many things the North Land needed,—roads, railway extensions, etc. The Premier practically promised that the more important of these needs should be attended to at an early date. A few days afterwards the New Liskeard man was on a holiday trip to the south and had the opportunity of hearing the Government speak again at Lindsay. At Lindsay the Premier Farmer of the Province again referred to the wants of the north. "They want roads, they want innumerable things, they want too much, but they will have to wait until we get our roads and other requirements down here," he said, according to the New Liskeard man.

And some people profess to be surprised at the growth of swearing in the North Land.

**OPENING OF BIG NEW STORE

**NEARLY 200,000 NAMES ON  
LIBERTY LEAGUE PETITION**

It will be remembered that petitions were recently passed around town for signatures by the Citizens Liberty League. These petitions urged the replacement of the un-British O.T.A. form of legislation by a form of Governmental control of the sale of liquors and permission to purchase wines and beers under a system to be devised by the Government, and that a referendum be held on the question of Government control. These petitions were very largely signed in Timmins and other sections of this part of the North Land. Indeed, it was a rare thing for anyone to refuse to sign, those approached usually being anxious to put down their own names and get others to sign as soon as they understood the nature of the petition. Apparently the petitions are being largely signed elsewhere in the Province also. Up to date a total of over 185,000 signatures is reported from Toronto headquarters and the intention is to continue the circulation of the petitions until there are half a million signatures.

**NEW COMPANY FORMED TO  
OPERATE ST. ANTHONY MINE**

A new mining company has been formed to take over and operate the St. Anthony Mine at Bucke, Ont., west of Cochrane. Last year this mine was operated under the management of Mr. C. P. Charlebois, but it has been closed for some time past. There is a mining plant on the property and considerable exploration and development work done. It is claimed that there are enough ore reserves to keep the mill busy for two years or more. The new company taking over the property is understood to include Mr. C. Lorne Campbell, formerly of the firm of Campbell & Deyell, Cobalt. Mr. Campbell will take personal charge of the conduct of the property. The mill has been put in first-class shape and has a capacity of 140 tons of ore a day. Arrangements are said to be under way with New

York interests to secure sufficient finances for the aggressive development of the St. Anthony Mine, and the actual active re-opening is expected at an early date.
