DOMESTIC EXTENSION DEAL

(Continued from page 1)

as the Purchaser shall be entitled to pursuant to the provisions hereinbefore contained, of the election of the Purchaser to exercise the option, or if the Purchaser shall fail to commence within five days from the execution and delivery of these presents the work of sinking the Purchaser's No. 3 shaft to a depth of 850 feet and carrying a drift from the said shaft at the depth of 800 feet or lower to and for one hundred feet or more easterly of the westerly limit of the Vendor's said lands at that level, or if the Purchaser shall fail to sink said shaft to a depth of 850 feet within three months from the execution and delivery of these presents, or if at the expiration of any period of thirty days computed from July 1st, 1916, the Purchaser shall have failed to do at least an average of 100 feet per month of drifting at such level toward the lands of the Vendor, or if, after the Purchaser has extended the said drift into the lands of the Vendor the Purchaser shall fail to expend at least \$5,000.00 during each and every period of thirty days in exploration, mining or development work on the said lands of the said Vendor.

The Purchaser may surrender this option at any time it sees fit by notice in writing to the Vendor, but so long as this option is in force the Purchaser shall on or before the 15th day of each and every month deliver to the Vendor a statement showing the progress during the previous month of the said drift certified by the General Manager of the Purchaser, and after the said drift has entered the lands of the Vendor the Purchaser will furnish to the Vendor on or before the 15th day of each and every month a statement certified by the General Manager of the Purchaser of the actual expenditures made during the previous month by the Purchaser in doing exploration, mining and development work on the lands of the Vendor.

The Vendor shall have the right at all times while this option remains in force to inspect the drifting and other work being done by the Purchaser under the terms hereof, and the Purchaser shall furnish the Vendor with a true copy of all assay reports of ores assayed by the Purchaser and taken from the lands of the Vendor or in the said drift within 100 feet of the westerly limit of the lands of the Vendor, and the Vendor shall be at liberty to make all such samplings and assays as it shall see fit of the ores and minerals found in the workings of the Purchaser on the lands of the Vendor or on the said drift within 100 feet of the westerly limit of the lands of the Vendor.

In connection with the work hereby required to be done by the Purchaser to keep this option in force, it is agreed that all time during which the work of the Purchaser is delayed by act of God, strikes of employees, failure of power or other cause beyond the control of the Purchaser, shall be excluded.

And be it further enacted that, if and when pursuant to the terms of such agreement The Dome Mines Company Limited, completes the purchase by paying 46,000 fully paid shares of the capital stock of The Dome Mines Company, Limited, such shares be distributed among the shareholders of this company of record at the close of business on the day upon which The Dome Mines Company, Limited, notifies this Company of its election to exercise the option to purchase set forth in the above agreement, pro rata according to their holdings, subject to this, that no fractional shares of the capital stock of The Dome Mines Company, Limited, shall be distributed but after each shareholder of this Company shall have received all such full shares as he shall be entitled to in such distribution the balance if any of said 46,000 shares of The Dome Mines Company, Limited, shall forthwith be sold on the Standard Stock Exchange, Toronto, for the best price obtainable and the net proceeds derived from such sale shall be distributed pro rata according to their respective rights among the shareholders entitled but for the provisions hereinbefore contained to a fractional share of the capital stock of The Dome Mines Company, Limited, in the distribution of the said 46,000 shares.

And be it further enacted that upon the said distribution being finally completed that application be made to the Lieutenant Governor in Council for the surrender of the charter of this company.
