## GET THE SLATES READY.

Within a few weeks the voters will have to exercise their prerogative and determine who shall be our town managers for the coming year. They will also be called on to decide as to the personnel of one half of the Board of Public School Trustees. These duties are important, and should not be dealt with in a haphazard, casual manner. Great responsibilities rest on our Council and Board of Trustees, and the voters should see to it that the men best fitted for the duties are elected. To be a Councillor of Timmins is just as honorable as to be a Councillor of Toronto, and, relatively speaking, just as important.

According to all accounts, the elections last year were carried out in a more or less cut and dried perfunctory manner. We do not say that the will of the people was over-ridden, but, from various causes, perhaps indifference, perhaps lack of opportunity, a careless, drifting course was pursued. As it happens, the present Council could have been a great deal worse, even if, perchance, it could have been a great deal better. That it could have been better is the people's own fault, that it has not been worse is their good fortune. The same may be said of the School Trustees, only more so. In both bodies individual daring and initiative have been glaringly absent. In both dilatoriness and procrastination have ruled the roost.

We suggest that the Mayor should call a public meeting wherein Councillors should render an account of their stewardship. Such a meeting is required by law in some sections of the Dominion. It gives a councillor the chance to recapitulate what he has done, and to state what he intends to do in the future, if a candidate for re-election. It also gives the electorate a chance to discover new material for office, and to voice its complaints and wishes. A financial report should also be made at this meeting. It may cause anxious moments to Mayor, Councillors and Trustees, but it invariably does good, and never harm. The people have the right to know. Let the meeting be called without trepidation and without delay.

A big bazaar was held on Tuesday in Bowway's Tailoring Parlors, in aid of the Building Fund of Byrnes Presbyterian Church.

Pastor Allan assumed the gavel of an auctioneer (unlicenced) and in short order disposed of the goods which remained. This phase of the affair created much amusement, and established the Pastor's ability in another line of endeavor than preaching.

Pastor Allan, on behalf of the President and members of the Ladies' Aid, thanked the people of Timmins for the manner in which they responded to the appeal for funds to assist the work.
