AGRICULTURAL HIGH SCHOOL FOR NEW LISKEARD

New Liskeard says that it has the promise of Hon. G. Howard Ferguson, Minister of Lands, Forests & Mines, that an Agricultural High School will be built by the Government at New Liskeard. As a consequence of this suggested promise, the New Liskeard Public School Board last week authorized the transfer of certain lands owned by the New Liskeard School Board to the Ontario Dept. of Lands, Forests and Mines. No one in the North Land will find any fault with the proposal to institute an Agricultural High School at New Liskeard. Such an institution would be of natural benefit to the North Country, and New Liskeard is a good location. But other important educational needs should not be overlooked. Indeed, there are some other educational needs of the North Land that should be financed and supported, even if the New Liskeard venture should have to wait a little. There is, for instance, the excellent High School at Haileybury. There has been some suggestion recently that the expense to the people of Haileybury is so burdensome that the High School may be closed. As it is the only High School north of North Bay and has given most efficient service, it should receive such Governmental assistance as would make its continued usefulness assured. Half a dozen Agricultural High Schools would not compensate for the closing of the Haileybury High School. The Government should make it clear beyond doubt that the Haileybury High School will not be allowed to cease its present usefulness for any lack of financial backing. If the Government were to give such assurance the announcement of the new school at New Liskeard would be received with general approbation.

AIRSHIPS NOW BRING USED ON MAIL ROUTES.

An air service for the carrying of mail between New York and Washington was inaugurated last Wednesday. President Wilson and Mrs. Wilson witnessed the start of the first airship carrying mail on this route. The trip was made in 3 hours and 20 minutes. Nearly seven hundred and fifty packages were in the mail, the total weight being 250 lbs. A large number of letters for the White House was included in this first aerial mail service. The utility and advantage of the airship for mail service were proven beyond question.

Despatches to the Exchange Telegraph from Christiania, Norway, also state that an aerial service for the carrying of mail between Aberdeen and Stavanger is expected to be opened at once. It is pointed out that economic interests between Great Britain and Norway are now so great that improved postal and passenger service is a necessity. This is where the great airship comes into service. The possibilities of the airship for mail and light freight can not be over-emphasized, and The Advance expects to see after the war this speedy method of transportation in very general use by the civilized nations.

Haileybury's tax rate this year will be 40 1/2 mills for Public School supporters and 47 mills for Separate School supporters. This is a reduction of several mills from last year's rate in Haileybury.

Cobalt is going to build a new fire hall to cost \$15,000. The Cobalt Council has also ordered two cars of tarvia to be used on the streets.

Mr. Dave Pierce, who has been recovering from his recent illness at Montreal, has returned to Camp and his many friends here will be pleased to know that he is well on the way to complete recovery.

An Italian Society is being organized here and large numbers of the men from Italy living now in Timmins are joining. The purposes of the Society include fraternal and social objects and the general improvement and advancement of the members.

Mr. Norris Howey returned last week from Toronto, having successfully passed the medical and other tests and being duly enrolled in the Royal Air Force. He has been placed on the R. A.F. Reserve and is home again waiting orders to report for service.

Bishop Latulippe will pay a pastoral visit to the R. C. Church here next Sunday and there will be special services on the occasion. Preparations are being made to give a suitable reception to the Bishop on the occasion of the visit.

Lieut. K. F. DeLong, of the R.A.F., left last Friday morning for the south for a further holiday before returning to active work again in the Air Service. Lieut. DeLong has made excellent progress to recovery from the injuries received in an aeroplane accident in Texas and expects before long to be back in his chosen branch of service to King and Country.

The regular meeting of the D.Y.B. Club was held on Monday evening at the home of Miss Poitras and a pleasant time enjoyed by the large crowd present. The next meeting will be held at the home of Mrs. Ellis. The D.Y.B. shipped a box on Saturday containing 239 pairs of socks and 9 shirts.

Bert Dewar will be here on Saturday, May 25th, (weather permitting), at Dalton's Corner, with a wagonload of Geraniums and Fuschias, for bedding out, at \$1.50 per dozen. Bring your baskets along to take them home. Also, English Wallflowers and other plants and cut flowers. Mr. Wm. Black, of South Porcupine met with an unfortunate accident on Monday. He was using a circular saw and had on a pair of cotton gloves to protect his hands from the rough wood. The left glove, however, proved a poor sort of protection from the saw, for a loose part of the glove caught in the saw and drew part of the hand with it. Mr. Black's thumb was badly cut, the bone being almost sawn in two. Prompt medical attention was given the injury, and Mr. Black is now carrying his arm in a protecting sling, but with good hopes that though the injury is a painful one it will not mean the loss of any part of the thumb or hand.

Mr. R. J. Ennis returned from Toronto on Sunday's "National."

A big drive started down the river this week, no less than 400,000 ties being in the drive.

The Women's Auxiliary of St. Matthew's Church are giving a Tea and Knitting Competition at Mrs. Meyer's on Thursday afternoon from 3 to 6.

Constable Greer left Saturday morning for North Bay, taking down to that town a Finlander who had been committed to an asylum for the insane.

Chief John Clark, Constable Greer and Officer R. Allen are at Haileybury this week as witnesses in the case against Consavitch, the Russian charged with making seditious utterances here in March. The cases against McHale on high-grading charges have been laid over from this court, but may come up for speedy trial later before the District Judge. Otherwise they will be heard at the Fall Assizes. During the absence of Chief Clark, Officer M. Salley is acting chief of police and J. D. Maclean is deputy in place of Constable Greer.

In order that present and past citizens of the United States of America may have opportunity in Timmins of complying with the resolution of the U.S. Congress and the proclamation of President Wilson, a public service of intercession will be held in St. Matthew's church on Thursday, May 30, (Memorial Day), "to pray Almighty God that He may forgive our sins and shortcomings as a people—that He will give victory to our armies, wisdom to those who take counsel on our behalf, and steadfastness to our people,—bringing us at last the peace in which men's hearts can be at rest, because it is founded upon mercy, justice and goodwill."

The fire brigade had a run Saturday afternoon to 27th Sixth Avenue, the informant travelling all the way to the fire hall, past more than one alarm box, to give the information that there was a fire in progress. The firemen, however, made up some of the time lost thus, by their speedy turn-out. When 27 Sixth Avenue was reached it was found that the fire had been extinguished by the capable work of the lady living in the house next door, her coolness and prompt and efficient action certainly preventing a more serious fire. It is thought that children playing with matches under the stairs may have caused the blaze, the owner, Mrs. Morrissey being away at the time. About \$25 damage was done by the fire.

It is funny how women will talk about women, and farmers will talk about farmers, and church people will talk about church people, and Friend Scotty Wilson will persist in talking about the dead. Friend Scotty has written another letter about the dead from South End, and in it he says:—"I do think, however, you might have mentioned that I pointed out the fact that the dead ones at Timmins are care fully stowed away at the morgue in the sand-hills, out of sight of the town. Are you ashamed of them?" No Friend Scotty, we are not ashamed,—only careful, and afraid. So long as the frost in the ground prevents real burial we would be afraid to let them go through to South Porcupine, for they might never get really buried then. Also, now that real burial is possible, the pollution of the afore-said morgue and the bodies at South End will be both carefully counted, so that no illegal transfers may be slipped over on us.
